

**MERCANTILE LICENSES**  
**SCHEDULE OF FEES**

Purpose. All license fees are imposed for the purpose of the regulation and control of the various professions, vocations, trades, businesses, callings or occupations hereinafter names.

Refunds or rebates. No rebate or refund of any license fee or any part thereof shall be made by reason or retirement of licenses from business or by reason of a change of location of business or by reason of fire or other accident or other casualty rendering use of the license ineffective.

When due. All license fees for conducting or engaging in any of the professions, vocations, trades, businesses, callings or occupations hereinafter listed at the places to be designated in the license certificate or in using any wagon vehicle, stand, store or place or thing for the sale of any goods or things, or for the type of services hereinafter designated, shall be as follows:

All businesses not classified or enumerated: \$50.00

Advertising agencies, advertising demonstration stores, catalog stores with mail order only: \$35.00

Amusement arcades: \$150.00

Auction stores: \$150.00

Auctioneer license, where the auction is not conducted at an auction store: \$50.00 per auction and \$10.00 for each additional day.

Automatic amusement machines or devices and video games in locations other than amusement arcades (both distributor and proprietor of premises where devices are located to be responsible for compliance): \$25.00 each.

Automobile repair shops, service stations, car washes and garages: \$50.00

Automotive taxicabs: \$50.00 per cab.

Billboards: \$50.00 each.

Car Rentals: \$100.00

Commercial sign businesses: \$50.00

Contractors, building, mason, plumbing, heating, sheet metal, etc. (with principle place of business in borough): \$50.00. Contractors, home improvement, flooring, basement and attic finishing, aluminum and other siding, etc. (with principle place of business in borough): \$50.00

Department stores: \$100.00

Express offices, moving and storage establishments: \$100.00

Garage Sales: \$10.00

Hotels, motels, motor lodges and motel efficiency apartments, not including restaurant: \$10.00 each sleeping room.

Ice cream and soda parlors: \$50.00  
Ice cream vendors: \$100.00 each vehicle.

Landscaping, gardening or nursery services, selling, soliciting, delivering or performing same: \$50.00

Laundry or dry-cleaning establishments, self service: \$50.00

Lumberyards, millworks: \$100.00

Machine shops: \$50.00

Newsstands and newspaper vending machines: \$50.00

Photographic studios and businesses: \$50.00

Pool and billiard establishments: \$25.00 each table.

Printing establishment: \$50.00

Restaurants, diners, lunchrooms or wagons and restaurant counter sections in other stores, no entertainment provided: \$50.00 Restaurant, entertainment provided: \$150.00

Retail establishments dispensing food, dry goods, clothing, hardware, accessories, furniture, notions and supplies of any kind: \$50.00

Rooming, lodging and boardinghouses: \$10.00 per sleeping room.

Ship and boatyards or marinas: \$150.00

Service stores and businesses, such as dry-cleaning establishments, tailors, shoe repair shops, shoe-shine parlors, dog kennels and animal hospitals, tool and equipment rentals, fur storage, furniture and other storage, upholstering and furniture repair, radio and television repair and other businesses considered to be of a service nature: \$50.00

Swim clubs, bathing beaches, bathing houses, cabana clubs, etc.: \$100.00

Wholesale supply houses, selling or dispensing materials and supplies of any kind: \$50.00

In the event that one establishment contains two or more related types of businesses, then the license fee shall be the sum of the two highest fees.  
The inclusion of any business or occupation in this section is not intended to indicate that any such business or occupation is a permitted use within the Borough. Permitted uses are established only by the Zoning Ordinance.
