5. MAYOR KALAKA-ADAMS - 2007 NEW YEAR MESSAGE:

Good morning. Happy New Year and welcome to Sea Bright's annual reorganization meeting. I extend a special welcome to Assemblyman Steve Corodemus who is joining us again, as he has for so many years. On behalf of the entire Governing Body, thank you for attending our proceeding this morning. I extend wishes for a wonderful, healthy and prosperous 2007 to everyone here as well as the entire Sea Bright community.

While this proceeding is a public meeting to conduct borough business such as the appointment and swearing in of officials, it also has become a time to give thanks to all who contribute to the betterment of Sea Bright. I must first recognize the members of our Borough Council, who devote their time and energy to Sea Bright on a daily basis. These individuals, who I am naming in order of length of service- Council President Jack Keeler, Maria Fernandes, Dina Long, Brian Kelly, Tom Scriven and our newest member, Peggy Bills - deserve much gratitude. In Sea Bright, each member of the governing body has significant job responsibilities, but serves purely on a volunteer basis. They, like I, get their "pay" from the knowledge that they are doing their best to improve the town we all live and love.

Also, serving on a volunteer basis are so many others, starting with our fire and first aid departments, which provide critical and vital services. As all who have received assistance can verify, our members are dedicated and professional, providing peace of mind for our town when an emergency occurs. In this regard, I must also recognize our superior police department. Not only do the police provide for our 24-hour safety, but also officers are the first to respond at emergencies. In fact, we are fortunate to have police officers who also are members of our volunteer squads. In addition, the community outreach, from home checks to the junior police program in the summer, creates a very positive image and relationship with Sea Bright's residents.

Thanks are in order for all who contribute on a volunteer basis - from the Planning/Zoning Board, which continues to be so aptly run with Chairman Lance "Chickie" Cunningham at the helm, to President Nancy DeScenza and the entire Sea Bright Board of Education, Brendan Flynn and the dedicated group involved with the library,

Felecia Stratton and the wonderful recreation volunteers, Ralph Clauer, who, despite his injury, together with the members of the

beautification committee, is responsible for so many projects including the beautiful Christmas decorations that we have all enjoyed so much this season - to the many others that contribute to our various events in other unselfish and unpublicized ways. Know that your efforts are truly appreciated.

We thank our employees and the professionals that are required to operate our municipality, many of who are with us today, for their efforts and dedication to Sea Bright. The responsibility for the day-to-day operation of our town rests with our employees and they do an excellent job.

In this message, I pause to look back as well as toward the future. As I complete three years as Mayor it seems both a very short time on the one hand and , particularly, if you ask my husband - by the way, thank you again, Jim, for your continued support and all for all that you do behind the scenes without seeking thanks or recognition...It seems an eternity since I started my term. But, when I say "eternity", I mean that in a good way.

In embarking on anything new, we all know that there is a learning curve and that certainly is the case with becoming an elected official. Each year I have learned more and feel more confident in having the information and resources to continue to improve Sea Bright. I have particularly benefited from the assistance of our borough employees. Our Borough Clerk, Maryann Smeltzer, is a true professional She not only capably performs her duties but she has added to her training and credentials and is active in organizations to keep up to date and in the forefront of her profession. I have sought out and utilized resources available to mayors to better perform my duties. I have been fortunate to establish not only wonderful working relationships with fellow mayors in our area as a member of the Two River Council of Mayors and elected officials that allow me to reach out and discuss common issues and concerns.

I believe that I can speak for all when I state that the greatest concern of the residents of Sea bright is to maintain a wonderful community with a great quality of life but also to keep our expenses - which results in the amount of taxes we each pay-in check. In this regard, unfortunately, we on the municipal level cannot directly affect many expenses. But, those we can control we must. While we have been unable, despite continued efforts, to change the unfair funding formula for Shore Regional High School, we can and have challenged and obtained reductions in the budget amounts.

I have been undertaking a review of all aspects of our borough financial obligations to determine how we cannot only control costs and expenses but also make reductions. The area of shared services is one in which our town is actively pursuing. In conjunction with our Finance Chair, Jack Keeler, I have reviewed our required professional services. For the year 2007, I am please to report that in no case, will there be an increase in the contractual amounts but in most cases, I have obtained reductions.

I look forward to other challenges and projects. Upon assessment and review of the Smart Growth Study, we will determine how to move forward. I look forward to expanding and beautifying the beachfront and boardwalk and creating additional uses and recreational opportunities. But we will proceed with such projects by means of applying for grants and other methods of funding to offset the costs as not to create additional tax burdens. We must respond to the state lawsuit regarding beach assess which to me is very unfortunate and surprising for the State to sue one of its own

towns. I intend to explore alternatives to lengthy and expensive litigation on this matter.

In what would be a financial, safety and convenient benefit to Sea Bright, we continue to explore a cell tower and contract. While we are a very small town both in size and in population, by virtue of our ideal location and the beauty of our beach, there may be other avenues for public/private partnerships that can benefit the town.

I look forward to working cooperatively with all members of the council, and, in conjunction with the employees, residents and businesses, making 2007 a great year. And as I have stated in my previous addresses, Sea Bright is the "the place to be," now more than ever. I than everyone once again and ask for everyone's continued efforts and commitment to Sea Bright.

Corporal Lovgren's wife Donna held the Bible while his family gathered around and Mayor Kalaka-Adams administered the oath of office.

Councilwoman Fernandes asked Mayor Kalaka-Adams if she would consider holding off the appointment of Borough Labor Attorney until both the personnel and finance committees are able to discuss this a bit further and to avoid a debate here.

Mayor Kalaka-Adams said she wanted to move on this appointment today and not at the next meeting.

Councilwoman Fernandes said that in order to look more conservative on spending Sea Bright has always used our Borough Attorney Arnette and he is recognized as a Labor Attorney with the Monmouth County Joint Insurance Fund, which is our insurance company. In the past if a case got to a point of being beyond Attorney Arnette's specialty, he would retain a colleague to help the town or we would go to our Joint Insurance Fund and retain their labor attorneys. Having said that I have nothing against Matthew Giacobbe but I think that perhaps we should decide either how this labor attorney could be better used or just having Attorney Arnette as our attorney for labor and for borough. We have a small number of employees so to hire a special attorney for a handful of cases that we might have during the course of a year, I do not think this is money well spent. The other thing is that Oceanport, which is a town larger than us, has just hired Attorney Arnette as Borough and Labor Attorney. I do understand Mr. Giacobbe's expertise is labor law. I understand, respect and appreciate that and what seems to be happening now is the bills are going too high. So, that is why we feel we should talk about this in committee before we got into it here today. But, if you want to pursue this unfortunately, I cannot support this today. If the Council would be willing to go back to committee, I think we could work out an agreement and better instruct our professionals as to when they should call the Labor Attorney or the Borough Attorney. It is a gray area right now and we should look at working out a fine-tuned plan and they know when they should go to one attorney or another.

Councilman Kelly said that in terms of the Labor Attorney and the costs there is no retainer involved and he bills only when someone requests his services. His firm provides labor counsel services to over thirty New Jersey towns and cities for example Hazlet, Marlboro, Tinton Falls, Wall and Middletown. There has been some confusion as to when to call the Labor Attorney and we are addressing this in the revised personnel handbook.

Councilman Keeler said the idea of a Labor Attorney came to us from the Joint Insurance Fund. Some years ago the Joint Insurance Fund had a guest speaker at a monthly meeting and she was a labor attorney and spoke of the advantages of a community having a separate labor attorney from the borough attorney and that is what started the thought process of hiring Mr. Giacobbe. The arguments that the JIF made to us then have also been expressed by the current JIF. Labor law changes regularly because of pressure groups working in Trenton representing both sides of the issue. We need someone who focuses on that body of law. In small towns, Borough Attorneys become familiar with many of the Borough Employees and the feeling expressed by the JIF is that over time, that could put the Attorney in an awkward position. Especially, if he has a working relationship with an employee and then there is a dispute between two employees and between the town. The Labor Attorney would then be called in to try to resolve it. Those arguments made sense to us and that is why we brought in the Labor Attorney. When we met with Monmouth Municipal Joint Insurance Fund recently, they asked us if we had a Labor Attorney and we answered yes and several people at the meeting said that this was great and they are worth their weight in gold. When I attend the JIF meetings there is an executive session at each meeting and we review all the current lawsuits, worker's compensation etc. It is shocking how much money goes out on these settlements. This is why JIF encourages towns to have a Labor Attorney. It is absolutely no reflection on the Borough Attorney. It is simply their experience, that it is better

to have one person focusing on Labor and who is at an arm's length relationship with the town employees. Our Labor Attorney does not come into Sea Bright. He does not come in contact with our employees on a regular basis as our Borough Attorney does. Therefore, he is not part of these bonds that naturally arise through human contact. That is the reason I was and still am enthusiastic about having a Labor Attorney. The man we have hired comes highly recommended and he is accessible and returns his calls promptly. He will give you answers right then on the phone. I think it is prudent for us to have a Labor Attorney and I would recommend that we move on this. The point that Councilwoman Fernandes raised about the grey area as to when we should call the Labor or Borough Attorney will be addressed and made clear for the Department Heads in particular. I have the greatest respect for Mr. Arnette I have known him for many years; he is very talented and very sharp. I just think there should be two separate people handling legal situations in our town.

Councilwoman Fernandes said she understood what Councilman Keeler said about the relationship between the Borough Attorney and the employees. We had a case where there was a conflict of interest and Attorney Arnette recused himself in that case. We did get someone else. I still would feel more comfortable with one attorney and I do not think we are in need of two attorneys.

Mayor Kalaka-Adams said that the experts are recommending just the opposite and it is advantageous for the town to have both a Labor and Borough Attorney. Mayor Kalaka-Adams said she spoke to the Mayor of Oceanport and they did not hire Attorney Arnette as a Labor Attorney he is their Borough Attorney. They have other lawyers for special cases they are litigating at this point.
