

**RESOLUTION No. 56-2015**  
**Person-to-Person / Place-to-Place Transfer**  
**Liquor License #1343-33-017-005**

**WHEREAS**, an application has been filed for a person-to-person/place-to-place transfer of Plenary Consumption Retail Liquor License, Number 1343-33-017-005, heretofore issued to TWBC III Incorporated for premises located at (inactive), Sea Bright, New Jersey; and

**WHEREAS**, the submitted application form is complete in all respects, all appropriate State and Township fees have been paid, and the license has been renewed for the current license term; and

**WHEREAS**, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated there under, as well as pertinent local ordinances and conditions consistent with Title 33; and

**WHEREAS**, the applicant has disclosed, and the issuing authority has reviewed, the source of all funds used in the purchase of said liquor license and the licensed business and all additional financing obtained in connection with the licensed business;
