

**RESOLUTION NO. 88-2015**  
**Chapter 201 Vehicles and Traffic**  
**Section 201-20. Two-Hour Parking in Designated Areas**

Councilmember Leckstein introduced and offered for adoption the following Resolution; seconded by Councilmember Kelly:

**WHEREAS**, the Borough Council of the Borough of Sea Bright established by Ordinance of the Borough Code, Chapter 201 Vehicles and Traffic, Section 201-20. Two-hour parking in designated areas; and

**WHEREAS**, Section 201-20. "Two-hour parking in designated areas" from May 1 to October 1, between the hours of 10:00am and 6:00 pm, vehicles may be parked for a period of no longer than two hours in such places as may be designated by the Chief of Police of the Borough of Sea Bright or his designee; and

**WHEREAS**, due to several parking issues that caused traffic and parking problems on Imbrie Place last year; Chief John Sorrentino designated that the two-hour parking on the outer perimeter of Imbrie Place be removed; and

**WHEREAS**, Chief Sorrentino recommended two-hour parking designated area on the inner cubed islands of Imbrie Place.

**NOW, THEREFORE, BE IT RESOLVED** that the Borough Council of the Borough of Sea Bright authorize the two-hour parking designated area on the inner cubed island of Imbrie by resolution of the Governing Body per recommendation of Chief Sorrentino; and

**BE IT FURTHER RESOLVED** that a certified copy of this Resolution be forwarded to the following:



I am requesting that a Resolution be passed under Borough Ordinance 201-20 for 2 Hour parking on Imbrie Place.
