

RESOLUTION No. 83-2016
AWARD OF CONTRACT
2015 ROADWAY PRESERVATION PROJECT
ATLANTIC WAY, BELLEVUE PLACE, WILLOW WAY

Councilmember Leckstein offered the following resolution and moved its adoption; seconded by Councilmember Kelly:

WHEREAS, on April 5, 2016 the Borough Council of the Borough of Sea Bright authorized the receipt of bids for the 2015 Road Preservation Project which includes improvements along Atlantic Way, Bellevue Place and Willow Way; and

WHEREAS, the Borough Clerk did duly advertise on April 8, 2016 to receive bids on April 19, 2016 for the 2015 Road Preservation Project Improvements Project; and

WHEREAS, in connection therewith two (2) bids were received by the Borough Clerk on April 19, 2016 from the following: 1) Black Rock Enterprises, LLC, Old Bridge, New Jersey for \$253,848.00, and 2) Cardinal Contracting Co., LLC, Southampton, New Jersey for \$389,389.00; and

WHEREAS, it was determined that the lowest responsible bidder meeting specifications for this bid was Black Rock Enterprises, LLC; and

WHEREAS, the Borough Engineer recommends that a contract be awarded to Black Rock Enterprises, LLC of Old Bridge, New Jersey as per their bid proposal for the 2015 Road Preservation Project at a cost not to exceed \$253,848.00; and

BE IT FURTHER RESOLVED that this award of contract is conditioned upon delivery and execution thereof within ten (10) days from the date of the within Resolution accompanied by such appropriate insurance certificate, affirmative action certificate and performance bonds as may be required by the specifications; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the following:


