

RESOLUTION No. 67-2016
AUTHORIZING THE BOROUGH OF SEA BRIGHT TO APPLY FOR
NEW JERSEY DIVISION OF HIGHWAY TRAFFIC SAFETY
2016 "CLICK IT OR TICKET" GRANT

Councilmember Leckstein introduced and offered for adoption the following resolution; seconded by Councilmember Bills:

WHEREAS, the safety and security of the citizens of the Borough of Sea Bright and surrounding areas is vitally important; and

WHEREAS, a large percentage of motor vehicle occupants injured in traffic accidents were not wearing seat belts; and

WHEREAS, the use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle accident; and

WHEREAS, the State of New Jersey Division of Highway Traffic Safety is participating in the National 2016 "Click It or Ticket" seat belt mobilization campaign from May 23 – June 5, 2016 in an effort to raise awareness and increase seat belt usage through a combination of enforcement and education; and

WHEREAS, grant funds in the amount of \$5,000.00 are available, with no local match, from the New Jersey Division of Highway Traffic Safety to reimburse police personnel for overtime for statewide seat belt enforcement; and

WHEREAS, the deadline to apply for the grant is April 30, 2016; and

WHEREAS, the Borough of Sea Bright Police Chief has recommended that the Borough apply for said Grant; and

WHEREAS, the Governing Body of the Borough of Sea Bright, County of Monmouth wish to apply for this seat belt enforcement grant from the State of New Jersey Division of Highway Traffic Safety.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, that the appropriate officials are hereby authorized to execute and sign any and all documents in order to effectuate the receipt of the aforementioned grant funds from the Division of Highway Traffic Safety for the 2016 "Click it or Ticket" Statewide Seatbelt Mobilization.


