

RESOLUTION NO. 21-2017
2017 SHARED SERVICE AGREEMENT
FIRE OFFICIAL/CODE ENFORCEMENT VEHICLE

Councilmember Leckstein introduced and offered the following resolution for its adoption; seconded by Councilmember Kelly:

WHEREAS, the Fire Official for the Township of Ocean Fire District No. 2 is also the Housing Inspector for the Borough of Sea Bright; and

WHEREAS, the entities have an arrangement whereby, the Borough of Sea Bright will pay to the Township of Ocean Fire District No. 2, an annual rental fee for the use of the fire official vehicle in the sum of \$600.00 and for the use as Housing Inspection the sum of \$300.00 for an annual total of \$900.00; and

WHEREAS, the Borough of Sea Bright and Township of Ocean Fire District No. 2 wish to enter into a shared service agreement for the term of January 1, 2017 through December 31, 2017; and

WHEREAS, under the terms of the Agreement, the Borough of Sea Bright will pay to the Township of Ocean Fire District No. 2, \$900.00 annually; and

WHEREAS, it has been determined by the Borough of Sea Bright and Township of Ocean Fire District No. 2 that it is in the best interest of both entities to share the expenses for a vehicle by eliminating unnecessary cost; and

WHEREAS, Michael J. Bascom, Chief Financial Officer of the Borough of Sea Bright, has certified that funds will be available in the 2017 Temporary Budget.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, that the shared service agreement be authorized as mentioned above and that the Mayor and Borough Clerk are hereby authorized to sign the agreement for 2017.

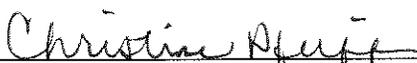

SHARED SERVICES AGREEMENT

**BOROUGH OF SEA BRIGHT
and the
TOWNSHIP OF OCEAN FIRE DISTRICT NO. 2**

(January 1, 2017 – December 31, 2017)

THIS AGREEMENT, made this 1st day of January 2017.

BETWEEN:

THE BOROUGH OF SEA BRIGHT, a municipal corporation of the State of New Jersey having its principal offices located at 1167 Ocean Avenue, Sea Bright, NJ 07760 hereinafter referred to as the "**Borough**".

AND:

THE TOWNSHIP OF OCEAN FIRE DISTRICT NO. 2, located at 2001 Sunset Avenue, Ocean, New Jersey 07712 hereinafter referred to as the "**DISTRICT**".

WHEREAS, the **District** employs a Fire Inspector who utilizes a vehicle provided by the **District** in the performance of services; and

WHEREAS, this individual is also employed by the **Borough** and wishes to use the vehicle to provide services for the **Borough** in the capacity of Fire Official and Housing Inspector; and

WHEREAS, the entities have reached an agreement to allow for the use of the vehicle and various equipment contained therein.

NOW, THEREFORE, BE IT RESOLVED, that in consideration of the promises exchanged herein, it is agreed as follows:

1. The **Borough** shall provide payment on an annual basis of \$600.00 for the use as "**Fire Official**" and \$300.00 for the use as "**Housing Inspector**" for a total of \$900.00 as set forth above and to assist thereby in many of the costs incurred concerning the vehicle and equipment.

2. The agreement shall be approved by resolution of each of the entities.

IN WITNESS WHEREOF each party has caused its authorized officials to sign and seal this Shared Services Agreement to the date first hereinbefore set forth.
