

**RESOLUTION No. 90-2017**  
**AUTHORIZING THE BOROUGH OF SEA BRIGHT TO APPLY FOR**  
**NEW JERSEY DIVISION OF HIGHWAY TRAFFIC SAFETY**  
**2017 "CLICK IT OR TICKET" GRANT**

Councilmember Leckstein introduced and offered for adoption the following resolution; seconded by Councilmember Birdsall:

**WHEREAS**, the safety and security of the citizens of the Borough of Sea Bright and surrounding areas is vitally important; and

**WHEREAS**, a large percentage of motor vehicle occupants injured in traffic accidents were not wearing seat belts; and

**WHEREAS**, the use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle accident; and

**WHEREAS**, the State of New Jersey Division of Highway Traffic Safety is participating in the National 2017 "Click It or Ticket" seat belt mobilization campaign from May 22 – June 4, 2017 in an effort to raise awareness and increase seat belt usage through a combination of enforcement and education; and

**WHEREAS**, the federally funded grant funds in the amount of \$5,500.00 are available, with no local match, from the New Jersey Division of Highway Traffic Safety to reimburse police personnel for overtime for statewide seat belt enforcement; and

**WHEREAS**, the deadline to apply for the grant is May 5, 2017; and

**WHEREAS**, the Borough of Sea Bright Police Chief has recommended that the Borough apply for said Grant; and

**WHEREAS**, the Governing Body of the Borough of Sea Bright, County of Monmouth wish to apply for this seat belt enforcement grant from the State of New Jersey Division of Highway Traffic Safety.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, that the appropriate officials are hereby authorized to execute and sign any and all documents in order to effectuate the receipt of the aforementioned grant funds in the amount of \$5,500.00 from the Division of Highway Traffic Safety for the 2017 "Click it or Ticket" Traffic Safety Grant.
