OFFICE OF EMERGENCY MANAGEMENT
"MUNICIPAL EMERGENCY MANAGEMENT COORDINATOR"
N.J.S.A. App.A:9-40.1

Councilmember Leckstein introduced and offered for adoption the following Resolution; seconded by Councilmember Keeler:

WHEREAS, the State of New Jersey Office of Emergency Management requires each municipality to appoint an "Emergency Management Coordinator", and

WHEREAS, the Municipal Emergency Management Coordinator, Office of Emergency Management for the Borough of Sea Bright shall serve a term of three years, and

WHEREAS, the Municipal Emergency Management Coordinator is responsible for the planning, activating, coordinating and the conduct of Emergency Management operations with the municipality; and

WHEREAS, it is the intention of the Borough Council of the Borough of Sea Bright to comply with the requirements set forth under the provision of N.J.S.A. App.A:9-40.1 of the State Disaster Control Act; and

WHEREAS, the Borough Council wishes to appoint Daniel J. Chernavsky, Detective, Sea Bright Police Department as the Municipal Emergency Management Coordinator for a three (3) year term commencing January 1, 2020 for a salary of \$3,000.00; and

CERTIFICATION OF FUNDS:

BE IT RESOLVED that the Borough Clerk is hereby authorized to forward a certified copy of this resolution to the following:


