- a. Continue discussion of event fees
- b. Discuss the possibility for waiving the insurance requirement for certain events: **Chapter 179.8**
- **A.** All applicants seeking a permit shall be bound by all applicable Borough ordinances, rules and regulations, except in such cases where exemptions have been requested and approved by the Committee in its approval of the special event. The applicant to whom the permit is issued shall be liable for all loss, damage or injury sustained by any person or property due to the negligence of the applicant during the course of the special event.
- **B.** The Committee shall set, based upon the size and scope of the event, an amount of liability insurance the applicant must carry in order to cover any liabilities that may occur as a result of the special event. If liability insurance is required, the applicant's insurance policy shall name the Borough as an additional insured. The maximum amount of insurance coverage shall be \$1,000,000.
- **C.** All applicants, regardless of whether liability insurance is deemed to be required, must execute a hold harmless agreement, the text of which shall be prepared by the Borough, before a permit will be issued. [Added 4-18-2017 by Ord. No. 9-2017]
