11. COMMITTEE REPORTS:

A. Beach/Education/Environment: Councilwoman Long reported that 285 beach badges were sold during the ½ price sale that would end March 31, 2010. The Clean Ocean Action spring sweep is April 24, 9am to 11 am. The Committee would meet with Executive County Superintendent Morris to discuss the Oceanport/Sea Bright district consolidation. Sea Bright would receive the disbanded Sea Bright BOE funds. The State Assembly is considering a Public School choice program bill allowing students to go to other schools out of their district.

B. Public Works/Building Department/Public Relations:

Councilman LoBiondo reported that Pillari Brothers picked up the damaged Beach Street pump for repairs and will cost about \$2,600. He said that the DPW did a great job during the most recent snowstorm. Members of the SBFD helped clear the roads of snow, which was a considerable savings to the Borough.

C. Police/Emergency Management/Insurance/Court:

Councilman Keeler reported that OEM Coordinator Mason set up an emergency response office to respond to any problems during the storm especially during the few hours of power loss and phone service. Demolition of the old Highlands Bridge will continue for more than a month. DOT project repaving along Ocean Avenue may begin in April. Sea Bright's court will be re-located to Oceanport commencing March 1, 2010.

D. Finance/Grants/Fire:

Councilman Murphy said that the Borough could lose the funding that was received for the long awaited delivery of the fire truck if comes after July 1.
