CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEE,
EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTEERS, INDEPENDENT
CONTRACTORS, AND MEMEBERS OF THE PUBLIC THAT COME INTO CONTACT
WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Borough of Sea Bright to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of Sea Bright has determined that certain procedures need to be established to accomplish this policy.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Sea Bright that:

- Section 1: No official, employee, appointee or volunteer of the Borough of Sea Bright by whatever title known, or any entity that is in any way a part of the Borough of Sea Bright shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitution rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough of Sea Bright's business or using the facilities or property of the Borough of Sea Bright.
- Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough of Sea Bright to provide services that otherwise could be performed by the Borough of Sea Bright.
- Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.
- Section 4: The Borough Administrator/Clerk shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.
- Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.
- Section 6: The Borough Administrator/Clerk shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough of Sea Bright as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.
- Section 7: The Borough Administrator/Clerk shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.
- Section 8: At least annually, the Borough Administrator/Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Borough of Sea Bright. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Borough of Sea Bright's web site: www.seabrightnj.org
 - Section 9: This resolution shall take effect immediately.
- Section 10: A copy of this resolution shall be published in the Asbury Park Press and the Sea Breeze Newsletter in order for the public to be made aware of this policy and the Borough

A. <u>Beach/Education/Environment:</u> Councilwoman Long said that the State v. Sea Bright, which is the beach access lawsuit, has been settled. They are working on beach improvements and residential permit parking. The CAT Committee developed a mission statement, set goals and objectives and will hold meetings twice a month until Memorial Day.

Public Works/Building Department/Public Relations:

Councilman LoBiondo was absent and Councilman Kelly reported that DPW did snow removal and salting during the December $19^{\rm th}$ snowstorm. To keep in line with the storm water management plan by bringing all vehicles to Conte's Car Wash in Long Branch.

E. <u>Personnel/Administration/Cultural Arts/Recreation:</u>

Councilwoman Bills reported that Friday Family Fun night begins in February from 7-9 pm for family activities. The personnel manual is being updated.

- F. Smart Growth/Flood Mitigation/Beautification: Councilman Kelly reported that they would be meeting with the Borough's Planner Mary Tangolics on plans for Phase I.
- MAYOR FERNANDES REPORT AND COMMUNICATIONS. •NJ Boat Commission met in Sea Bright on January 13. The Commission voted unanimously to authorize the NJ Marine Police to initiate a slow speed/no wake temporary test period for the entire 2010 boating season. The test area includes shore to shore on the Shrewsbury River from the Highlands Bridge south to Sedge/Gunning Islands (Buoy #28). Data collected by the NJ State Marine Police will be used to determine if the regulation will become permanent. Although this is a test period, boaters violating the slow speed/no wake regulation can be issued a summons. Additional buoys, if available, will be placed on the river at the discretion of the State Police. We will be responsible for contacting NJDOT and the County to request permission to have signs placed on their respective bridges advising boaters that this is a slow speed/no wake area. We will work with the NJ Marine Police for proper wording. The NJ Boat Commission enjoyed meeting in Sea Bright and may consider having future meetings here.

The NJ State Library has created a web site that assists NJ residents and businesses to help them through tough economic times. The site has a wide range of useful links that may be of assistance to local officials that are trying to assist their residents address their concerns. The site http://gethelp.njlibraries.org has links and references in the following areas: NJ Work Tools, NJ Financial Tools, NJ Housing Tools, NJ Health Tools, NJ Parental Tools, and Tools for Seniors.

The NJLM has advised that the White House has established a centralized website www.whitehouse.gov/HaitiEarthquake, which will provide informational tools and resources for individuals and communities seeking to support relief efforts. You can contribute to the Red Cross online, or donate \$10 to be charged to your cell phone bill by texting "HAITI" to "90999."

We should be moving our court operations to Oceanport by March 1, 2010.

The Monmouth County Board of Freeholders will be holding one of their "out of town" meetings in Sea Bright on Thursday, March 25, 7 PM. I would like to thank Borough Administrator Maryann Smeltzer for arranging this for us.
