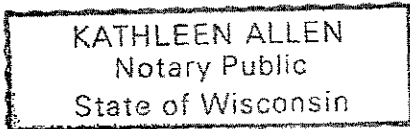

PLEASE TAKE NOTICE that on Tuesday, March 26, 2024 at 7:30 P.M., at the meeting of the Planning/Zoning Board of the Borough of Sea Bright, Sea Bright Beach Pavilion – 3rd Floor, 1097 Ocean Avenue, Sea Bright, New Jersey, or at such time as the Board may thereafter adjourn, a public meeting will be held with regard to the application of Frank Camuso, at which time you may appear in person or by agent or attorney and present any objection which you may have to granting this application. 1. 130-39C – Accessory structure proposed height of 20.8' where 15' is the maximum;
2. 130-39C – Accessory structure existing setback non-conformity (2.6' where 5' is required) is proposed to be exacerbated on one side due to the proposed second-floor addition;
3. 130-38D(1)f. – The existing accessory dwelling structure is a non-conforming use. The application is to enlarge this accessory dwelling structure, thereby expanding a pre-existing non-conforming use. This requires a use variance.

The applicant also reserves the right to request any and all variances and/or waivers which are necessary or may become necessary during the public hearing process.
