8. <u>INVOCATION:</u> Father Michael Manning delivered the invocation.

9. COUNCIL PRESIDENT WILLIAM J. KEELER - 2011 ADDRESS:

Councilman Keeler said that the all volunteer fire department was very dedicated. The new fire apparatus should be arriving in approximately three months. Pat Mason, OEM Coordinator and his crew responded exceptionally well during Hurricane Irene. First Aid responds to many calls throughout the year. Sea Bright police department greatly assists the community and its focus is not patrolling the highway. The Council will be looking toward the future for more involvement toward shared services which would keep costs down. He commended the Borough staff for their dedicated work and professionalism.

Councilman Kelly reported that in 2011, the engineer worked on the three-phased beach front project and the Council will seek to bond to fund the project. Last year, the beautification committee planted flowers around town and the landscaping project is complete behind Borough Hall.

Councilman Murphy reported that Sea Bright's financial picture is solid. He said that the proposed beach front projects would generate revenue.

Councilwoman Bills said that the town's library is true cultural art center having programs for children, books, movies and art exhibits,

Councilwoman Bills said that for 2012 the recreation department will be offering Mommy and Me classes, a volleyball clinic for ages 13-17, a Valentine bingo scheduled for Friday, February 17, summer swim lessons donated by Councilman LoBiondo of the Surfrider Beach Club and the Mayor's wellness program.

Councilman LoBiondo reported that the town received a grant to repair the bulkheads in downtown Sea Bright and the installation of a pump on Osborne, 1.3 million dollars.

Mayor Long said that Hurricane Irene devastated the shore line and the dunes. The 2011 beach badge sale surpassed the previous year with over 1000 beach badges sold before Memorial Day. The plan is to replace the public beach facility, upgrade the playground and extend the boardwalk. Funding is available from the DEP settlement. The SPCA's trap-neuter-release program immunized and sterilized nearly 100 stray and feral cats with no cost to the taxpayers. Because of this program no kittens were born on our beach front. This program would not have been possible with the volunteerism from Ada Lilly Medina and Frieda and George Finegan,

10. MAYOR DINA LONG - 2012 NEW YEAR MESSAGE: Good afternoon. I'd like to begin by thanking God and my husband Rob who made it possible for me to be standing here today.

Many of you know that it's because of my husband Rob that we first came to Sea Bright, when he was assigned as the new Pastor at the first united Methodist church of Sea bright. I was extremely uneasy about this; it was his first pastor job, I was going to be a 'pastor's wife' and we were going to be moving to a new community.

When we pulled up in front of the church, we were greeted by this well-dressed older lady who welcomed us and said, in a sweet southern drawl, "Hi, My name's Rista, and I'm the only hooker in Sea bright". I thought to myself, this might be ok after all. (Rista Hooker, god rest her soul.) Well Rob's time at the church came to end, but it was already too late; we had the sand in our shoes, our son Sam was born, and we were staying.

I am privileged to have served three terms as a member of the borough council before taking the oath of office today. During this time I've had the opportunity to talk with so many of our residents, and I'm proud to say that I've never seen such an eclectic group of individuals collected on one blessed little 3-mile sand bar. Yet, for as much diversity and individualism as we have, I am always struck by the common value that all of us share: the deep love of our town. (We know we live on the best place on earth...sunrise in the morning, sunset in the evening, and the breathtaking ocean.)

Yes, we have different opinions of what a future sea bright should look like. Yes, from Trenton there are formidable challenges ahead for small communities like ours. Yes, we are short of money.

But there's one thing my experience on this governing body affirms time again: When we all work together, we succeed.

As a member of the Council, the initiatives of which I am most proud came about not from one individual person but through the efforts of a collective.

As examples, our seasonal reduced speed limit was the result of working with residents who were concerned about traffic and pedestrian safety. Our half price beach badge is thanks to a resident, who asked the question, why don't we? Why don't we, indeed. There's a Japanese proverb that says none of us are as smart as all of us together. It's often quoted, I think, because it's true.

Our town is changing. Our state is changing. Progress is going to happen, because the people and taxpayers demand it.

So I invite every person in this room to work with me, and the good people you see sitting up here, to be a part of it. Thank you.
