RESOLUTION NO. 171-2012 BOROUGH OF SEA BRIGHT RESOLUTION TERMINATING THE EMPLOYMENT OF CHARLES YINGLING

WHEREAS, on or about August 13, 2012, the Borough sustained disciplinary charges against Borough employee Charles Yingling (hereinafter referred to as "Employee"), and;

WHEREAS, the Employee created a hostile work environment by stalking both male and female employees, and;

WHEREAS, the Employee failed to abide by his job description and over stepped his authority by directing others, and;

WHEREAS, the Employee improperly used the Borough's property, cellular telephone camera, non work purposes, and;

WHEREAS, the Employee made several false accusations against fellow employees, and;

WHEREAS, the Borough issued a penalty of two (2) days suspension for the Employee's conduct, and;

WHEREAS, the Borough and the Employee are parties to a Settlement Release and Last Chance to Return to Employment Agreement (hereinafter referred to as "Agreement"), and;

WHEREAS, the Employee executed the Agreement on March 8, 2006 and Mayor Kalaka-Adams executed the Agreement on April 4, 2006 on behalf of the Borough, and;

WHEREAS, Paragraph 6 of the Agreement provides that any future discipline imposed on the Employee will be grounds for termination, and;

WHEREAS, the Borough Council having considered the disciplinary charges sustained against the Employee determines that it is in the best interest of the Borough to terminate Employee's employment, effective immediately, and;

NOW, THEREFORE, BE IT RESOLVED, that effective immediately, the employment of Charles Yingling is hereby terminated; and

BE IT FURTHER RESOLVED, that the Municipal Clerk/Borough Administrator and Mayor, are authorized and directed to take all steps necessary to effectuate the purpose of this Resolution.
