These impacts require debris removal, recycling, staging, sorting from public roads and public property critical to the welfare and recovery of the Borough.

WHEREAS, as per N.J.S.A. 40A-11-6 any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold; and,

WHEREAS, an emergency exists affecting the public health, safety or welfare requiring the immediate performance of services; and,

WHEREAS, the OEM Coordinator recommends that the Governing Body award the contract to Ash Britt, Environmental, 565 East Hillsboro Blvd, Deerfield Beach, Florida 33441 whose services will support the Borough of Sea Bright for its recovery needs in an amount not to exceed \$250,000, and;
