The year started off well, we had a good summer and then Hurricane Sandy hit. Volunteers and non profits started pouring in to help sort things out and get things back to normal. Our Borough professionals all stepped up using their special skills and ties to help us rebound. 2012 year in review - primarily spoke about Sandy and all the relief efforts from volunteers to government initiatives. Mentioned all borough personnel and first responders and thanked them for all their hard work and long hours. Also thanked Rumson P.D. and the National Guard. 2012 ended very badly for Sea Bright but we have cleaned up faster than most other coastal towns. FEMA the Governor and Lt. Governor have sincerely offered to help us in our rebuilding efforts and we are taking advantage of that. No deaths were reported as a result of the storm.

Our own Sea Brighters, our first responders, our Borough Hall employees and your Council.
