Mayor Long called the meeting to order and requested those present to join her in the Pledge of Allegiance to the Flag. - 7:00pm

OFFICIAL PROCLAMATION

SEA BRIGHT BOROUGH COUNCIL WILL PROCLAIM AND PARTICIPATE IN NATIONAL BIKE MONTH - MAY 2014

WHEREAS, the bicycle is a viable and environmentally sound form of transportation and an excellent form of recreation; and

WHEREAS, millions of Americans will experience the joys of bicycling during the month of May through educational programs, races, commuting events, trail work days, helmet promotion, charity events, or just getting out and going for a ride; and

WHEREAS, the Henry Hudson Trail attracts thousands of bicyclists each year from all 50 states and from across the globe, providing economic, health, and scenic benefits to citizens of New Jersey and the world; and

WHEREAS, these bicycling activities and attractions have great potential to have a positive impact on New Jersey and Sea Bright's economy and tourism industry and to stimulate economic development by making the state attractive to businesses and citizens who enjoy the out of doors and healthy lifestyles; and

WHEREAS, creating bicycle-friendly communities has been shown to improve citizens' health, well-being, and quality of life, to boost community spirit, to improve traffic safety, and to reduce pollution and congestion; and

WHEREAS, May has been declared National Bike Month for each of the last 58 years, and is so again in 2014; and

WHEREAS, the League of American Bicyclists, the New Jersey Bike and Walk Coalition, bicycle clubs, schools, parks and recreation departments, police departments, hospitals, companies and civic groups throughout New Jersey will be promoting bicycling as a leisure activity as well as an environmentally-friendly alternative to the automobile during the month of May 2014; and

WHEREAS, the education of bicyclists and motorists as to the proper and safe operation of bicycles is important to ensure the safety and comfort of all users; and

Now, therefore, be it resolved that the members of the Sea Bright Municipal Government hereby recognize the month of May 2014 as National Bike Month and Bicycle Safety Month, and the week of May 14-18, 2014, as Bike to Work Week; and

Be it further resolved that the Sea Bright Municipal Government urges all who support bicycling to participate in the events planned and urges all road users to share the road safely with bicyclists.

REMARKS FROM THE AUDIENCE: (limited to 3 minutes)

The Public Comment portion of this meeting allows members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

1. Charlie Rooney, 196 Ocean Avenue, spoke on behalf of residents who are very upset about the handling of the dissolution of the library. Mr. Rooney went through a schematic list of dates and details as he knew them and believes the Borough did not act in good faith. He feels it was totally unnecessary to demolish the building and believes the Borough Council acted recklessly in destroying the library. He thanked Councilmembers Bills and Keeler for voting to save the library.
2. Elizabeth DiGuilio, 1540 Ocean Avenue, stated that the manner in which the library was demolished was disrespectful and disgraceful and not representative of the Sea Bright she knows.
3. Liz Von Ziegesar, 174 Ocean Avenue, stated she thinks that Councilman Murphy and other members of Council have become so focussed on the town moving forward that they ended up destroying a vital part of the town they were entrusted to protect - the sense of community. They didn't take in to account all those who use the library on a regular basis. She hopes the town will give the community back an even better library and a sense of community before it is too late.
4. Bob Neuhooff, 1184 Ocean Avenue, asked if there was any extra expense involved in demolishing the library on a Saturday vs. a week day and who authorized it to be done on a Saturday... Acting Administrator Verruni responded that there was no extra expense incurred - there were no additional personnel on duty. And, it was the contractor who contacted us to see if we had a problem if they did the demo on Saturday. Councilman Murphy reiterated that the contractor wanted to do it a few days early and they contacted our Public Works Superintendent.
5. Fran Rooney, 4 Surf Street, asked who the staff members were who were approached for the approval that authorized it to come down? Mayor Long said we can get a rundown of who did what when.
6. Mary Ann Chevalier, 666 Ocean Avenue, stated she became involved with the library when she first came to town and noticed on any plan she saw that the library was always slated to come down. She was given assurances that that was not going to happen and that the library was going to be safe.
7. Susie Markson, 1187 Ocean Avenue, said it is a shame that the library building is gone although she wasn't attached to it, but the way that it happened was awful and breeds mistrust. She doesn't think people are so upset about losing the building but about the way it happened.
8. Janet Hentschel, 7 E. Church Street, had two questions - what is the standard procedure when the Borough gets work done - do they get written estimates. She said with the library, we only got one written estimate - two were verbal so we didn't follow procedure and that is wrong. Mayor Long responded that we would follow up on the procedure that took place.
9. Adelina Fernandez, 628 Ocean Avenue, said that for those that were against the location, congratulations, mission accomplished.

10. Vince Lapore, N. Broadway, Long Branch, had a question directed to Mr. Verruni and asked for clarification about an item the 1/16/14 workshop meeting - "areas in need of redevelopment?" Mayor Long responded that the discussion was that the Council expressed their desire to find out how to go about doing the "area in need of" study and decided to carry in to workshop discussions of what that process is and whether or not they want to entertain that process. There will be more discussion on this but nothing is under way. Mr. Lapore also thanked the Council members for responding to his concerns about the wording on the 20/20 presentation and the working was changed.

11. Fran Rooney, 4 Surf Street, asked if Council was going to comment on any of their questions or concerns. Mayor Long responded with a summary of the facts that led up to the demolition and that she is working with the Council and is committed to making sure a new library worthy of Sea Bright is rebuilt.

12. Marisol Rooney, 196 Ocean Avenue, stated as taxpayers, they should have been made aware of something of this magnitude and feels it showed a lack of respect to everyone involved.

13. Bob Neuhoff, 1184 Ocean Avenue, asked if any of the members of Council was asked how they felt about the library coming down on Saturday vs. a weekday the following week. Councilman Leckstein said there was never a set date - it was to be determined by the contractors availability.

14. Liz Von Zegeisar, 174 Ocean Avenue, suggested that procurement was not followed, the demo happened in record time and that they had no idea the library would be down before the next Council meeting.

15. Linda Richter, 2 Village Road, explained that she went to the Borough Hall on the Friday before the demolition of the library to see if they could get the signs out of the building and she was assured that the building would not be down before Monday.

16. Peggy Saxton, 1184 Ocean Avenue, said she feels that the destruction of the library is destroying the arts which are so important. Also, the library link should be taken off the website.

Councilman Kelly commented that they voted at the December 17, 2013 meeting to demolish the library and did not set a date and at that time already had plans to build a new library. This is not the end of the library in Sea Bright - there will be a new one on the oceanfront which will be completed by Memorial Day, 2015. Councilman Murphy said there will be a temporary one put up in the next couple of months.

17. Charlie Rooney, 196 Ocean Avenue, said that the first vote to take the library down on December 17 and the next Council meeting wasn't until January 21 and you knew the library was coming down between those dates. Wanted to know why they had to rush it and if they would vote the same today if they had to do it over again.

18. Bob Neuhoff, 1184 Ocean Avenue, asked who knew the library was coming down that Saturday and if there was extra expense because it was on a Saturday. Councilman Murphy responded that there was not.

Mayor Long called for a five minute adjournment.

FOR DISCUSSION

1) Cell Tower - Councilman Kelly wanted to re-ignite this discussion to see where the Council currently stands on this subject. He explained what the space/shed could be used for - storing vehicles, etc. The location of this shed is one of the controversial concerns. It was decided to continue discussion at the 2/13/14 Workshop meeting. Councilman Leckstein stated he renewed his objection - thinks this would be a big mistake.

2) Replacement of Bioxide system at the middle pump station

3) Rehabilitation of Sanitary Sewers in the Beach and Center Street areas

Acting Administrator, Joe Verruni, explained that the above two items (added New Street to No. 3) are in need of repair. We are hopeful that we will get some funding from Sandy but not absolutely certain. Mr. Verruni met with our CFO and a funding mechanism would have to be put in place for these items. The Borough Engineer has provided costs estimates for both projects. We will have an introduction of the Bond Ordinance for both.

4) T&M - Revised Engineering Cost Estimates- Mayor Long asked Engineer Flor to walk us through the changes to the cost estimates of the Municipal Parking Lot and the Anchorage Lot project. Engineer Flor explained that the original plans for the parking lot included the library. Once the library was removed and the plans for the new beach pavilion were expanded the parking lot plans had to be revised and reconfigured. Mayor Long asked CFO Bascom, as Engineer Flor mentioned, this additional work is to accommodate the new building, can we cost share with the beach utility and under bond anticipation cover some of these costs that we know are going to go towards the construction of the building. CFO Bascom responded that we can at least with some portion of the cost. Councilman Keeler asked if we could explore the possibility of expanding River Street. Engineer Flor explained that the Department of Transportation would only let us do that if we agreed to reconfigure the traffic signal which would be a large additional expense.

Also, the cost for the Anchorage Lot needs to be revised because the rest room was originally designed by Robert Adler & Associates. They were replaced by another architect, Sonnenfeld & Trocchia who will be doing the inspection now. As a result, we need to authorize an additional fee. The project is partially funded by CDBG funds.

5) Beach Office, Councilman Murphy informed Council that a trailer will be coming in shortly for a library. Also a business trailer for a beach office and a container for storage. Councilman Leckstein added that we are looking to break ground for the new beach pavilion this year so nothing can go in that area.

6) Business District Parking, Acting Administrator Verruni - Business Community has asked that the front row of parking lot to be designated for business district. Mr. Verruni will get a copy of the Ordinance for the next meeting for review.

UPDATES (FYI)

- The new Village Post Office officially opened on Saturday, February 1. The VPO is located at Bain's Hardware (1092 Ocean). The hours are: 8 am - 6 pm Mon thru Fri; 8 am - 5 pm on Saturday and 9 am - 1 pm on Sunday.
- Dog and Cat Licensing deadline was January 31, 2014.
- Our website is currently down while we undergo maintenance and upgrade to a new and improved web site. The current site can still be accessed via a link on the

webpage. Mayor Long asked Councilmembers to check and make sure department heads have provided all the information needed for the new web pages.

MAYOR LONG ANNOUNCEMENTS

Mayor Long also announced that FEMA is transitioning out of here and so what was known as the FEMA Joint Field Office is no longer - it is now called the Strategic Recovery Office. We are not sure what this means for us but we are continuing to work the process to make sure that Sea Bright collects every dollar it is entitled to under the Stafford Act for the damages caused by Sandy.

The Two River Council of Mayors Association meet once a month. The Oceanport Mayor with a consultant called Millenium Strategy are applying for a planning grant so we can make a true regional coordination among all of the towns along the river with our mitigation activities. Oceanport as the lead is applying for a grant through the US Department of Interior Hurricane Sandy Coastal Resiliency Competitive Grants Program. Mayor Long signed a letter of support to compete for one of the grants.

We have been able to make some headway on two of the Sea Bright 20/20 projects. The first is the housing survey. Through contacts at the University of Delaware, we met with their Disaster Research Center to talk about having grad students perform the work of the housing survey. It would be mail, outreach and data collection. Sea Bright 365 Marketing is a Program saying that Sea Bright is open all year campaign, and encouraging people to visit our business district. Towards that end, Michelle McMullin and I met with VIACOM executives - they did some brain storming and came back with we need to do a little more strategic insight before we proceed. Viacom has committed to come to Sea Bright and do some focus groups March 26 & 27 and would like to meet with elected officials, members of communities and business owners and then will report back to us with a plan.

St. Bernard Project partnership with Sea Bright Rising. St. Bernard Project, out of Louisiana are experts in rebuilding homes - allowing people to leverage their repair dollars. They should be here by mid March. This program is suited to help people who want to fix their house and get home but simply don't have the money.

Engineer Flor brought to the Council's attention she was contacted by Gianforte to ask that they received bids for the televising and cleaning of the sewer lines for all of their municipalities. They put SB in as an alternate as we weren't sure we wanted to join the contract since we didn't know the cost. Administrator Verruni said that he spoke to Gianforte and told them we would decide after our 2/18/2014 meeting.

REMARKS FROM THE AUDIENCE (limited to 3 minutes)

The Public Comment portions of this meeting allow members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

1. Bob Neuhoff, 1184 Ocean Avenue, asked about the status of the collapsed sidewalk on his street caused by Sandy.
2. Liz DiGuilio, 1540 Ocean Avenue, asked about getting the books for the library from CBA - hopes that the town can pack up and bring the books back to the temporary library. Administrator Verruni said that we have spoken to Joan Walsh and are waiting to hear back from her with a date she wants the books moved.
3. Maryann Chevalier, 666 Ocean Avenue, brought to the Council's attention the dangerous situation for bikers riding past the beach clubs. Will discuss at next workshop.
4. Janet Hentschel, 7 E. Church Street, thanked Mayor Long, the Police Chief and Council for putting up street signs on East Church Street. Also asked if there would be a time designation on the business district parking signs. Also asked if the BSB website could be linked to the new Borough website. In addition, expressed her concern about the conditions behind the police station....the discarded debris, the generator and the gas tank.
5. Linda Richter, 2 Village Road, thanked the Mayor for the resolution for the bicycle plan. Please encourage residents via our website to get community support. Asked if we could

invite Bike New York to Sea Bright. Need to have our sidewalks shoveled and a sidewalk in front of the beach clubs. Need better communication.

6. Heather Bedenko, 400 Ocean Avenue, Sea Brighters Embracing Action and are still meeting and looking for ways to help the town. invited to dinner. Some concerns are abandoned properties, beach pavilion - are they citizens or just Councilmembers on the committee - want to make sure it is what the citizens need. Community would like more updates on how we are using Sea Bright 20/20. Post-Sandy wrap-up with the public - need to use what we learned to do better in the future. Also said that people are unhappy about the workshop meeting scheduled in the morning vs. evening and are unable to attend. Finally, asked how people get in touch with the St. Bernard Project, Mayor Long answered that they need to contact Sea Bright Rising.

7. Butch Hentschel, 7 E. Church Street, asked if the fence around the Sunoco station could be changed to something more attractive and if it is a temporary fence.

8. Barbara Nadler, 656 Ocean Avenue, thinks the beach clubs look nice but are enormous and wanted to know what that is doing to their tax basis. Mayor Long explained that each Club will be inspected after construction to make sure they complied with what the Planning Board approved and then the tax assessor reviews and adjusts the tax as appropriate. Also asked what can be done with the abandoned properties - some places are horrendous. Members of the Council and the Borough Attorney responded that it is a lengthy process and it is underway. Thanked the Council for all they do.
