Vince LaPoire, 45 Marine Terrace, Long Branch, thanked Mayor Long and Councilman Keeler in their attempt to bring the budget to the people at the recent Workshop Meeting and feels Town Hall Meetings are a great way to hear the voice of the residents. Suggested a non-binding referendum by the "people" so the Council could see their thoughts on the matter.

Mark Pappas, Sunrise Condominiums, feels there has been enough discussion about the taxes but now there needs to be something done. He stated he was happy to see Governor Christie here about the seawall but is concerned that the repairs aren't targeting the wall in south beach. Mayor Long and the Borough Engineer explained the scope of work and detailed the locations that were damaged by Sandy which are the only areas that will be repaired by FEMA and DEP.

Adelina Fernandez, 628 Ocean Avenue, asked if the Borough is going to install parking meters in the parking lots and if so, would residents have passes? Mayor Long explained that Council is looking into it but no decisions have been made.

John Guarino, 8 East Church Street, asked about the status of the Anchorage Apartment Lot. Mayor Long summarized where things stand - the project still needs to be approved by the Joint Budget Oversight Committee in Trenton; a hearing is scheduled for September 18, 2014.

Jean Kingman, 36 Waterview Way, asked if DOT has been contacted about widening the turn lane at the Rumson Bridge in front of the Anchorage Apartment.

## ORDINANCE #14-2014 AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 130 "LAND USE", ARTICLE IX DESIGN STANDARDS, SECTION 130-59 DESIGN STANDARDS FOR SPECIFIC USES, (Bulkheads) OF THE CODE OF THE BOROUGH OF SEA BRIGHT, 1998

**BE IT ORDAINED** by the Borough Council of the Borough of Sea Bright in the County of Monmouth, State of New Jersey that Chapter 130 entitled "Land Use", Article IX Design Standards, Section 130-59 Design Standards for Specific Uses of an Ordinance entitled "Code of the Borough of Sea Bright, 1998", be and the same is hereby amended and supplemented in the following manner:

# **SECTION 1**

#### CHAPTER 130 "Land Use"

Article IX, Design Standards for Specific Uses is hereby amended to include the following, with all other section not listed remaining the same.

§130-59 Design Standards for Specific Uses:

G. Bulkheads

- 1. This ordinance applies to locations that abut the Shrewsbury River and/or the Sandy Hook Bay. In areas where beach exists along the river, new bulkheads will not be required; however, previously existing bulkheads and any new bulkheads shall be maintained and improved in accordance with the provisions below and shall be located in the same line as the abutting bulkhead to the north and south, permitting beach to the west of said bulkhead.
- 2. Notwithstanding the provisions of Section §130-46C, in the case of previously existing bulkhead structures, destroyed by reason of windstorm, fire, explosion or other act of God or the public enemy to an extent of less than 50% of the linear foot of total bulkhead on the property, then such destruction shall be deemed to be "Partial Destruction" and may be rebuilt restored or repaired. Nothing in this chapter shall prevent the strengthening or restoring to a safe condition any wall, floor or roof which has been declared unsafe by the Building Inspector or other competent legal authority having jurisdiction.
- 3. All newly constructed bulkheads, bulkheads repaired that exceed more than 50% of the linear foot of bulkhead on the property, and damaged bulkheads that are not "partially destroyed," as defined above in Section B, shall be constructed at a <u>minimum</u> elevation of 7 feet (NAVD88) and shall be constructed of steel, aluminum, vinyl or other approved material. All connections to adjacent bulkheads shall be constructed in a manner to provide a water tight connection. All bulkhead designs and connections shall be designed by a Professional Engineer, licensed in the State of New Jersey.

- 4. All existing bulkheads that are damaged to a condition that can be determined as "partial destruction" as defined above in Section B, can be rebuilt, restored or repaired to existing conditions.
- 5. All property owners requesting permits to construct new bulkheads or repair existing bulkheads shall be required to submit all plans to the Municipal Zoning Officer.
- 6. Bulkhead construction is subject to review by CAFRA and/or Waterfront Development and/or the Coastal General Permit Process.

## SECTION II

All other ordinances or parts thereof enacted prior to the adoption of this ordinance are hereby repealed to the extent of such inconsistency.

#### SECTION III

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjusted invalid such subparagraph, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

#### **SECTION IV**

This ordinance shall take effect as provided by law after its final passage.

# Moving proposal for Police Department/Temporary Firehouse

Borough Administrator Verruni asked Council to consider putting the temporary firehouse and police department on the west side (Ocean Avenue side) of the Peninsula lot vs. the east side (beach side) as we already have utilities in place in that location. This location was originally earmarked for the temporary library. Borough Engineer Flor explained the changes in specs that this move would require. Councilman Lamia inquired about sewer lines and if they would be installed. Borough Engineer explained the process of bringing the lines in to the beach side location. Mayor Long would like to get the Library Committee's recommendation before Council makes a decision. Council agreed to have a decision and prepare to authorize the Engineer to move forward at the October 7, 2014 Regular Council meeting.

# **COUNCILCOMMITTEE REPORTS:**

# **BEACH / PUBLIC RELATIONS:**

Committee Chair Lamia reported he is waiting on the year end totals for the beach proceeds. We had good feedback on our beach manager, Don Klein, and would like to consider him to come back next year and reported we are in the process of winterizing the beach equipment and securing it for the winter. Councilman Lamia addressed the complaint received about the debris washing up on the beach which was a result of the sand pumping in Monmouth Beach. There is grant money available to help with our recycling efforts. Met with Public Relations Committee and they are preparing a mission statement and goals. Councilman Lamia is doing an IT infrastructure review to make sure we are spending wisely.

# BUILDING DEPARTMENT-CODE ENFORCEMENT/COURT/PUBLIC WORKS & CULTURAL ARTS:

Committee Chair Leckstein reported Public Works has applied for a tonnage grant in the amount of \$10,000. Public Works has replaced the emergency auto-dialer which calls out when abnormal activity occurs at the pump stations after being struck by lightning (September 6). Regarding Code Enforcement Councilman Leckstein was happy to report that 1260 Ocean Avenue will begin getting cleaned up tomorrow. Reported progress on all other matters

# FINANCE / INSURANCE / GRANTS:

Committee Chair Keeler reported the budget review process will begin in approximately three weeks and gave a rundown of the process. Councilman Keeler is working with the NJ League of Municipalities to get a condensed copy of the presentation they make to newly elected officials on how the budget process and taxation work at the varies levels of the State which we can distribute to the public. T&M is resubmitting an application to DOT for resurfacing Willow and Atlantic Way...we applied last year but did not receive. Councilman Keeler attended a JIF meeting - they are confident that the Monmouth County JIF will be able to maintain a dividend policy. Reported Progress on all other matters.

Progress was reported in Committee Chair Bills' absence.

# PUBLIC SAFETY / POLICE FIRE OEM / WATER SAFETY:

Progress was reported in Committee Chair LoBiondo's absence.

# **SEA BRIGHT RECOVERY / MASTER PLAN / BEAUTIFICATION:**

Committee Chair Kelly reported the Beautification Committee is planning for the fall plantings and cleanup and will hire a professional landscaper to provide these services. Councilman Kelly recently did a drive through town with the landscape architect and they will be submitting a plan to the Beautification Committee. Councilman Kelly reported the Borough is still in the permitting process with the state concerning the beach pavilion and are meeting intermittently with the architect to come up with a final plan. Councilman Kelly anticipates we will receive grant money to hire a professional planner and will have a Borough Master Plan completed soon. Reported Progress on all other matters.

# MAYOR DINA LONG – Reports and Communications

Mayor Long complimented the Recreation Committee on a successful summer program for Sea Bright's children and for providing child care at our upcoming Town Hall meeting.

Mayor Long thanked and acknowledged the Library Committee for their perseverance and willingness for work with the Borough on getting a solution that everybody is comfortable with for a temporary library.

The Sea Wall project as proposed will be displayed in Borough Hall.

Mayor Long recognized Mr. Eugene Freed for his efforts in trying to get publicity for our school tax situation with Shore Regional. Mr. Freed reached out to the Asbury Park Press and was able to get an article highlighting Sea Bright's painful situation. This article caused other mayors to reach out who are in similar situations. We would like to get a committee of residents together who are willing to work independent of the governing body to see what recommendations they can come up with.

Mayor Long reported she recently met with NJ Economic Development Authority with regard to our Streetscape Grant; partial monies have been approved for Sea Bright but not the entire grant amount. We will continue working with the EDA to find other funding sources for the Streetscape application but we look favorable to move this forward next year.

We have two Town Hall meetings coming up:

1. Saturday, September 20 from 7-9 pm at Holy Cross - an event in partnership with NJ Future - a screening of the documentary "Shored Up." Child Care will be provided.

2. Thursday, October 9 - at Borough Hall; NJ Futures will bring their sea level rise maps - projections for future of sea level rise for Sea Bright to discuss flood control efforts in the borough in the past and future.

# **<u>REMARKS FROM THE AUDIENCE</u>** (limited to 3 minutes)

The Public Comment portions of this meeting allow members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

Charlie Rooney, 196 Ocean Avenue, suggested a possible location for the cell tower flag pole might be the end of River Street or in Swing Bridge Park. Also commented on the costs of the temporary fire house - Council should consider putting it in a location so it can be reused vs. knocking it down and throwing that money away.

Linda Lamia, 2 Village Road, distributed cell tower drawings on behalf of Bob Morrone and read a statement from him regarding the illustrations. Ms. Lamia asked Council to approve a resolution mandating all elected officials or residents working for the town are current on their taxes.

Elizabeth DeGuiglio, 1540 Ocean Avenue, commented M&S Waste has damaged their newly resurfaced parking lot with their garbage truck. Borough Administrator Verruni reported the Borough has contacted M&S on this matter and are awaiting a response.

John Guarino, 8 E. Church Street, asked if it would be possible to add a webcam to the cell tower. Also suggested adding banners for the businesses to advertise on the tower.

# REGULAR MEETING MINUTES

Eugene Freed, Ocean Reef, thanked Mayor Long for her efforts and for speaking out on our behalf at the school board meeting. Mr. Freed a committee will be established by a fixed date so they can get to work on changing this funding formula. Council members discussed contacting our Legislatures for their input.

Mark Pappas, Sunrise Condominiums, urged Council to just bypass the legislatures - we already know what they are going to say. Nothing will get done and suggested we take this on from a different angle. Councilman Keeler and Mayor Long explained to those present the efforts taken over the past years to try to resolve this funding formula issue.
