**ORDINANCE NO. 19-2016**

**AN ORDINANCE AMENDING AND SUPPLEMENTING THE GENERAL CODE OF THE BOROUGH OF SEA BRIGHT, CHAPTER 201 ENTITLED VEHICLES AND TRAFFIC, SECTION 201-42. RESIDENTIAL PERMIT PARKING DESIGNATED**

**BE IT ORDAINED** by the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, as follows:

**SECTION I:** Chapter 201, "Vehicles and Traffic", Section 201.42, "Residential Permit Parking Designated", subsection A of the Code of the Borough of Sea Bright is hereby amended and supplemented to read in full as follows:

"A. No person shall park or cause to be parked any vehicle on streets or parts of streets as described within the following sections unless an appropriate and current parking permit issued by the Borough of Sea Bright is displayed on said vehicle for those streets or parts of streets as described or listed herein:

Front Street	East
<b>New Street</b>	<b>North/South</b>
Normandy Place	East
North Way	East
<b>Peninsula Avenue</b>	<b>North/South</b>
<b>River Street</b>	<b>North/South</b>
South Street	North
Surf Street	North
Via Ripa	South
Waterview Way	North

**SECTION THREE:** All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies

**SECTION FOUR:** If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

**SECTION FIVE:** This Ordinance shall take effect immediately upon its passage and publication as required by law.
