MINUTES REGULAR MEETING BOROUGH OF SEA BRIGHT

SEA BRIGHT, NEW JERSEY

Mayor Long called the meeting to order at 7:00 pm and requested those present to join her in the Pledge of Allegiance.

Mayor Long read the following Compliance Statement:

Good Evening Ladies and Gentlemen. This Meeting Is Now Called To Order:

<u>REMARKS FROM THE AUDIENCE</u> (limited to 3 minutes)

The Public Comment portion of this meeting allows members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

Al Persisto, 174 Ocean Ave, stated he supports the proposed paid parking due to the Borough's need to increase revenue but believes that we must provide specialized parking for the businesses. Mr. Persisto stated he agrees with the Planning Board conducting studies on properties in town for redevelopment because many of them are fire hazards; the properties have been sitting vacant for too long and something must be done.

Condrad Paulus, 31 Center Street, stated the bulkhead looking better than expected, it is clean, neat and stronger however it prevents people from enjoying the end of the street. Ms. Paulus requested the town build a deck on the street side of the bulkhead. Councilman Kelly commented that they are meeting next week to discuss this exact issue and hopes to have plans for similar projects on each street.

PJ Rotchford, Peninsula Ave, expressed his concerned about the dirt piles on the empty lot on Peninsula. Now that it is getting warmer, the dirt is becoming drier and will become problematic on windy days. He questioned if there is an Ordinance that addresses this.

Brian George, owner of North Shore, explained that he is sensitive to the fact that the Borough needs revenue, however it should not be at the expense of the businesses. Mr. George said there needs to be a happy medium between the town collecting revenue and the prosperity of the businesses. Mayor Long suggested having 30 minute parking spaces in front of the businesses.

Carl Toole, 10 Imbrie Place, supports paid parking and encouraged Council to move forward with it. Mr. Toole said he believes Sea Bright is a destination and visitors will not stop coming here if meters go up . He also believes that it is good governance to take this path and fully encourages the Borough to go through with this.

Jason Yachanin, co-owner Perspirology, supports the study for the redevelopment investigation downtown; the property next to his studio at 1054 Ocean Avenue is deteriorating and he would love to see that turned into a garden for people to visit.

Katy Fraggos, co-owner Perspirology, said she is not completely opposed to paid parking but would encourage Council to consider the businesses and patrons in their plan. There are so many hurdles that the businesses have to go through and this just adds to it.

Bob Morrone, 15 Sandpiper Lane, sympathizes that the Borough needs revenue; however he believes that the town should not go through with the paid parking system. Mr. Morrone said there needs to be accommodation for the businesses; this will not encourage new businesses in Sea Bright.

Linda Lamia, 2 Village Road, thanked the Mayor and Council for all of the time they devote to the Borough. Ms. Lamia requested Council give the paid parking plan the time and attention it deserves before moving forward and urged them not to fast tract this project without a reasonable plan; please do not make the beach goers angry and want to travel to another beach. Ms. Lamia asked the Borough consider the following before moving forward; maximize the amount of parking spaces in the municipal lot, increase the beach access fee, create a plan for businesses to encourage people to purchase ice cream in a 10 minute parking spot, prepare our visitors with a proposed plan and amenities that they will appreciate next year when paid parking is in place. Ms. Lamia asked that the Administrator review and conduct performance evaluations on the DPW staff. She would like see more supervision of that department.

Butch Hentschel, 7 East Church Street, stated his opposition of the paid parking and feels that people come to Sea Bright because parking is free. Mr. Hentschel had a list of questions on how the paid parking will operate, how the Borough will manage internally, and the residents and businesses will be accommodated. Mayor Long explained that they are not able to answer most of his questions until there is a vendor and actual equipment. Councilman Kelly said that this is something that he will go over later in the meeting. Mr. Hentschel asked if paid parking is allowed in the P-House parking lot because it was acquired by a grant. Mayor Long explained that the P-House lot was not funded through grant money and does not have restrictions regarding paid parking. Mr. Hentschel asked the Borough not to rush this system until they have a well thought out plan.

Vincent LePore, 38 Ocean Terrace Long Branch, does not believe that this governing body is prepared to vote on paid parking and suggested adding \$10 to the beach fees instead of paid parking. Mr. Lepore believes there are many expenses involved and the money will not go to paying down debt service. He also expressed strong opposition to the redevelopment investigation. He explained that he knows how eminent domain and redevelopment affects people negatively from past experience in Long Branch and thinks this plan is developer driven. Mr. Lepore feels a rehabilitation zone is the way to go. Attorney McLaughlin pointed out that the Resolutions on the agenda have nothing to do with eminent domain, tax abatements or redevelopment zones. They are requesting the Planning Board to simply review the indicated zones and give feedback on eligibility of redevelopment.

Marianne McKenzie, 612 Ocean Avenue, expressed that she is conceptually open to paid parking; however her concern is that there has not been an adequate plan developed. She suggested that the price to get on the beach be raised to \$10 for additional revenue. Ms. McKenzie said paid parking is something worth studying and the Borough should engage the businesses when forming a plan. Ms. McKenzie also questioned the legal noticing of the redevelopment investigation process that resulted in the postponement of the planning board review.

SECTION I

CHAPTER 201 "Vehicles and Traffic"

Article VI, Handicapped Parking is hereby amended to include the following to the schedule, with all other sections not listed to remain the same.

Sub-Section 201-27.1 Restricted Parking Space (s)

Name of Street	Location
15 Church Street	North Side

SECTION TWO: All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies

SECTION THREE: If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and publication according to law and upon filing with the Monmouth County Planning Board.

Councilman Rooney explained he has researched paid parking over the past six months and was quite surprised with what he learned from business owners in other towns - all whom opposed the idea but have realized it has helped their businesses. Councilman Rooney explained that the Borough needs to generate revenue and truly believes paid parking will impact Sea Bright positively.

Councilman Keeler recognizes we need revenue, but would hold off on paid parking for this year until it is researched properly and recommends raising the daily beach fee to generate additional revenue.

Councilman Lamia explained he is generally not opposed to pay parking but feels raising fees is not the only way to solve financial problems. Councilman Lamia does not recall one savings strategy proposed since he has been on Council. Councilman Lamia stated paid parking will affect residents and businesses, not just visitors, and feels that if we put a good plan together, paid parking might work for us in the future.

Councilwoman Bills said she is not opposed to the pay parking but also feels it is too soon to charge for parking as the town and businesses are still coming back from Sandy. Councilwoman Bills understands both sides but doesn't feel strong enough either way so she felt she must abstain.

Mayor Long explained where we are - the subsequent vote of the Council needs to be the development of the "parking program" which will spell out all the details.

Councilman Kelly addressed the final details to be addressed and detailed the "Pay to Park Plan" draft below.

Pay to Park Plan

Overview:

Sea Bright has been considering a pay to park system for its Municipal lots for several years. Many Monmouth County beach communities utilize this system in various forms. Generating additional town revenue from user fees is becoming more commonplace. Utilizing pay to park in various forms also helps create turnover to aid businesses from all day parking places. Sea Bright hopes to utilize our existing Municipal lots in a more efficient manner, raise revenue, help our businesses and residents as well as provide greater access to our beaches.

Plan Components:

- 1. Utilize our existing Municipal lots for a pay to park system. Anchorage, P-House, Municipal, and Borough Hall lots will make up the pay to park plan.
- 2. There are more than 600 spaces in these areas that can be utilized in our parking system.
- 3. Realizing about 100 spaces will not be available for pay to park. First row of Municipal and P-House lots will be a combination of 30 minute, free parking, employee parking, residential parking for units fronting Ocean Avenue.
- 4. The season will be from the Friday before Memorial Day through Labor Day.
- 5. Hours of operation will be from 9am-6 pm.
- 6. During storm emergencies pay parking can be suspended by the Mayor, Borough Council, and/or Chief of Police.
- 7. Payment can be made at a kiosk or by a smart phone application. Kiosks will take cash or credit cards. There will be 1 kiosk in Anchorage, 2 in the Municipal Lot, and 1 in the Borough Hall Lot.
- 8. The preferred vendor is utilized by a number of the local beach Municipalities. Five vendors submitted RFPs and were interviewed.
- 9. The cost will be \$1.00 per hour. Most surveyed communities are also at \$1.00 per hour.
- 10. A small service fee will be added for those using a credit card and or the mobile application to offset the bank and application charge.
- 11. Violation of the hourly rate will be at the same rate that currently exists for 30 minute and business parking violations.
- 12. Ocean Avenue apartment residents will be issued a sticker for all vehicles registered to that address to be affixed to the vehicle.

- 13. Special officers will be trained in parking enforcement, to also collect revenue and make minor repairs to the kiosks.
- 14. Numbering system will be painted on asphalt surfaces and gravel lots will have wheel stops with numbers.

Revenue Projection:

We have over 600 spaces in the 3 Municipal lot locations. Assuming 100 are utilized for residents and/or employee/business parking several scenarios can be developed.

At 35% occupancy 175 spots, revenue will reach \$133,000 per year.

At 25% occupancy 127 spots, revenue will reach \$95,000 per year.

Annual maintenance is included for the first year. Thereafter approximately \$10,000 will be allocated for upkeep.

Councilman Lamia commented his biggest concern is that we will not be ready when this is put in place - people can go anywhere and pay to park for the beach.

WHEREAS, the Borough of Sea Bright Planning Board adopted the official Borough of Sea Bright Master Plan pursuant to <u>N.J.S.A</u>. 40:55D-28(a) in April of 1989, and subsequently adopted a re-examination report to said Master Plan on November 11, 2008; and

WHEREAS, the official Borough of Sea Bright Master Plan and re-examination report provide that various locations throughout the Borough of Sea Bright should be considered for designation as redevelopment areas pursuant to the Local Redevelopment and Housing Law, <u>N.J.S.A</u>. 40A:12A-1 et seq.; and

WHEREAS, <u>N.J.S.A</u>. 40A:12A-6, authorizes the governing body of a municipality, by Resolution, to authorize its Planning Board to conduct a preliminary investigation to determine whether any area of the municipality is an area in need of redevelopment; and

WHEREAS, the Borough Council of the Borough of Sea Bright considers it to be in the best interest of the Borough to have the Borough of Sea Bright Planning Board conduct such an investigation regarding property known on the Borough of Sea Bright Tax Maps as listed below:

ALLIED LUMBER PROPERTY Block 19 Lot 2

WHEREAS, the present buildings and improvements or lack thereof at the aforementioned properties by reason of obsolescence, and/or general deterioration and/or design and/or obsolete layout or non-existence thereof may be detrimental to the public health, safety, and general welfare of the community, thereby requiring redevelopment to better serve the Borough of Sea Bright; and

WHEREAS, the provisions of the Local Redevelopment and Housing Law explicitly vest the Planning Board with the authority to conduct a preliminary investigation so as to determine whether some or all of the aforesaid properties meet one or more of the statutory criteria set out in the Local Redevelopment and Housing Law so as to be designated as an area in need of redevelopment.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Sea Bright as follows:

1. The Planning Board of the Borough of Sea Bright is hereby authorized to conduct a preliminary investigation of the properties listed in this Resolution to determine whether all or some of the aforesaid properties should be designated as an area in need of redevelopment; and

2. The Planning Board shall, in the course of conducting this preliminary investigation, engage the services of Christine Cofone as Professional Planner, and other professionals engaged by the Board, to assist in the creation of a redevelopment study embodying said preliminary investigation for the above-referenced properties; and

3. That said preliminary investigation shall also, upon completion, result in the conduct of a public hearing by the Planning Board, on notice to all affected property owners, as to whether any or all of the aforesaid properties should be designated as a "condemnation redevelopment area" as required by N.J.S.A. 40A:12A-6; and

BE IT FURTHER RESOLVED that the Planning Board shall take all other measures as required of it by the Local Redevelopment and Housing Law, upon completion of this investigation and conduct of a public hearing, on notice to all affected property owners, to make a final decision and recommendations which shall be reported to the Borough Council for its consideration.

COUNCIL COMMITTEE REPORTS:

BEACH / PUBLIC RELATIONS / GRANTS:

Committee Chair Lamia reported we are ready to go with the SeaBreeze. We are spearheading the beach readiness and have new lifeguard stands. The Borough sold 3,300 pre-season badges and believes that it is a great program. Beach Manager, Don Klein, is looking to adjust lifeguard hours to provide additional coverage on the beach as well as looking to improve beach activities. Councilman Lamia will look into allowing dogs on north beach and will work with NJ Fish and Wildlife. The dunes made it through the winter and the dune grass is starting to grow and turn green. We have seven sponsors and the signs been delivered to public works for installation - \$7,000.

FINANCE / INSURANCE / COURT / VOLUNTEERS:

Committee Chair Keeler commented that Mr. Bascom sent out a letter to the state asking for forgiveness for our Sandy related loans which would be a major help to our financial recovery . The JIF selected Sea bright as one the towns for its most improved member in regards to effective safety practices and procedures in the Department of Public Works. The JIF is much more active in working with police and public works to ensure safety programs. Councilman Keeler reported we are still trying to figure out the position of public defender and issues regarding insurance coverage. Councilman Keeler reported a friend came across a pin from the Sea Bright chapter of the Order of Knights of Pythias; she would like to donate the pin from the town.

PERSONNEL/ LIBRARY / RECREATION:

Committee Chair Bills said as for recreation they are currently developing programs. They are looking for volunteers for the summer recreation camp. The library is going to execute a membership fee for non-residents to generate revenue. Councilwoman Bills thanked Councilman Rooney for the monthly organ recital program. Personnel...progress.

PUBLIC SAFETY / EDUCATION:

Committee Chair Rooney reported progress on both committees.

PUBLIC WORKS / BUILDING DEPARTMENT/ CODE ENFORCEMENT SEA BRIGHT 365 & CULTURAL ARTS:

Committee Chair Leckstein proudly announced that 1260 Ocean Avenue has been approved for a new residential structure and will be demolished soon. Councilman Leckstein reported the farmers market has been authorized for the 2016 season and will begin on Thursday, May 19 from 2-7 pm which is completely volunteer based. Sea Bright Kite Day will be April 30th.

SEA BRIGHT RECOVERY / CAPITAL PLAN / FLOOD CONTROL / BEAUTIFICATION:

Committee Chair Kelly said the Mayor signed off on the cell tower agreement and is now back in the hands of Verizon. Regarding Flood Control, our engineering firm T&M will be applying for a continuous bulkhead grant for the downtown area. There will be a beautification meeting next week to firm up spring flower planting and to look at options to beautify the new bulkheads.

MAYOR DINA LONG – Reports and Communications

Mayor Long reported there was a community stakeholders meeting for the Rumson bridge replacement and that they are working with the state DOT to propose some changes to the traffic flow on the Sea Bright side. There will be public meetings in both Rumson and Sea Bright. There are proposed changes with the traffic light at the bridge and widening the highway. Mayor Long said this project is most likely a year or two away.
