Mayor Long called the meeting to order at 6:07 pm and requested those present to join her in the Pledge of Allegiance.

REMARKS FROM THE AUDIENCE (limited to 3 minutes)

The Public Comment portion of this meeting allows members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

Linda Lamia, 2 Village Road, understands that the Sustainable Jersey application has been rejected and that we must re-file correctly by November 2nd. She questioned why we pay Borough employees who lack the ability to complete this task when there is a committee in place to complete this application properly. Mayor Long explained that Councilman Leckstein and the Borough Clerk's office have been uploading documents and obtaining information needed for certification. Ms. Lamia stated she feels this has been unsuccessful and that we should reach out directly to the staff at Sustainable Jersey for help. Additionally she would like a sustainable plan that includes an appropriate vehicle inventory.

Elizabeth Degiulio, 1540 Ocean Avenue, expressed how pleased she is that the referendum passed and she is looking forward to our new facilities. The library fundraiser is this Saturday and tickets are available at the library and Beachwalk Cafe for \$30 and hopes to see everyone there.

Arlene Baglino, Island View Townhouses, wants to thank the council for all the hard work they put in for passing the referendum – and questioned how far along the beautification/streetscape project is. She expressed her concern about head out parking in the downtown. Mayor Long explained that head out parking would be at the direction of the NJDOT. Councilman Rooney said that head-out parking is actually the safest because people are not opening their door into a bike lane. Councilwoman Bills commented that she was not a proponent of head out parking until she saw statistics on how much safer it was.

Elizabeth Degiulio, 1540 Ocean Avenue, questioned when the repaving of route 36 will take place. Ms. Degiulio is concerned about the crosswalk by Sunrise Condominiums. Administrator Verruni stated that they have not yet discussed the restriping however they will definitely take this concern into consideration. Councilman Keeler commented that he would like to see a new crosswalk on Ocean Avenue on the north side of Peninsula Avenue. Fran Mullen from T&M said that the Borough should let the DOT be aware as soon as possible of any concerns and requests.

WHEREAS, on April 21, 2015, the Borough Council of the Borough of Sea Bright awarded a contract to R. Kremer & Son Marine Contractors, LLC of Brick, New Jersey for the Reconstruction of Six Bulkheads and New Stormwater Pump Station in the contract amount \$1,199,880.00; and

WHEREAS, on October 20, 2015, Resolution #101-2015 authorized the re-consideration to the base bid, to include Alternate A1, A2, A3 & A4 as submitted in the original bid package that awarded a contract to the lowest responsible bidder, R. Kremer & Son Marine Contractors, LLC of Brick, New Jersey for the Reconstruction of Six Bulkheads and New Stormwater Pump Station in an new contract amount of \$1,525,705.00; and

WHEREAS, the Borough Engineer, Jaclyn Flor, submitted Change Order No. 1 dated October 13, 2015, identifying two unforeseen issues with the bulkhead and storm drain installation on South Street resulting in an increase of \$41,517.25 and various items were reduced to reflect current as-built quantities resulting in a decrease of \$41,520.00 resulting in a net decrease of \$2.75 to the total contract amount; and

WHEREAS, the Borough Engineer, Jaclyn Flor, submitted Change Order No. 2 dated January 5, 2016, identifying a reduction of \$4,080.00 in Items #27, #30 and #A1-15 to reflect the current as-built quantities and Item #10 increased \$4,080.00 to reflect current as-built quantities, resulting in a zero cost change; and

WHEREAS, the Borough Engineer, Jaclyn Flor, submitted Change Order No. 3 dated February 16, 2016, increasing items No. 8, 9 and 24 which include additional paving, drainage items and adding an inlet necessary to avoid an existing unforeseen sanitary lateral at the end of Osborne Place in an amount not to exceed \$26,750.00; and

WHEREAS, the Borough Engineer, Francis W. Mullan, submitted Change Order No. 4 dated October 17, 2016: Item 41) an increase of \$6,500.00 for additional construction efforts to remediate the Osbourne Place ponding issues, and Item 37) a decrease of \$6,500.00 due to a revision in the testing requirements for the pump station testing on Osbourne Place, resulting in a zero cost change; and

WHEREAS, Change Order No. 4 also identified Item A2-1) an increase in the contract of \$37,400 for Kremer's demobilization and remobilization costs as a result of the postponement of the River Street work until April 1, 2017 in an amount not to exceed \$37,400.00.

RESOLUTION NO. 167-2016 ADOPTING AXA EQUITABLE'S SPECIMEN DEFERRED COMPENSATION PLAN AND SERVICE AGREEMENT

Councilmember Leckstein introduced and offered the following Resolution for adoption; seconded by Councilmember Kelly:

WHEREAS, in order to attract and retain qualified employees there exists a need to adopt and implement a Deferred Compensation Plan for employees of the Borough of Sea Bright (hereinafter referred to as "Employer") which will provide employees the opportunity to enhance their financial security at retirement through savings of compensation on a tax-deferred basis as provided by Section 457 of te Internal Revenue Code of 1986, as amended ("Code"); and

WHEREAS, there is no direct financial cost to the Employer to adopt and implement both a Deferred Compensation Plan and Service Agreement; and

WHEREAS, the Employer made requests for proposals from two or more approved contractors, including AXA Equitable Life Insurance Company (hereinafter referred to as "AXA Equitable) for the administration of the investments of funds under a Deferred Compensation Plan including providing Prototypical Plans and Service Agreements that meet the requirements of the Municipal, County and Authority Deferred Compensation Programs Rule N.J.A.C. 5:37; and

WHEREAS, the Borough Administrator reviewed the proposals of the responding contractors of deferred compensation services; and

WHEREAS, it was determined that AXA Equitable has the ability to: (1) maintain complete records of accounts; (2) manage accounts with absolute fidelity; (3) provide advice concerning various categories of investments; and (4) provide continuing consultation to participants; and

NOW THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Sea Bright in the County of Monmouth, State of New Jersey, that:

(a) effective as of the date of this resolution the Deferred Compensation Plan provided by AXA Equitable and assigned the plan identifier: 66-PD-Equitable-053107 by the New Jersey Division of Local Government Services, is hereby adopted and signed by the Employer.

It is hereby acknowledged that the said Deferred Compensation Plan is substantially similar to one on which a favorable Private Letter Ruling has been previously obtained from the federal Internal Revenue Service except for provisions added by reason of The Small Business Job Protection Act of 1996 (United States Public Law No. 104-188), the Tax Payer Relief Act of 2001 (United States Public Law No. 105-34), and the Economic Growth and Tax Relief Reconciliation Act of 2001 (United States Public Law No. 107-16), and all such provisions are stated in the plan in terms substantially similar to the text of those provisions in the Code Section 457 including pertinent applicable Treasury Regulations. The use of the Ruling is for guidance only and acknowledges that for Internal Revenue Service purposes, the Ruling of another employer is not considered precedent.

- (b) the Mayor and Borough Administrator are authorized to execute the Service Agreement (bearing the identifier: 66-SA-Equitable-053107 assigned by the New administrative and investment services. There has been no collusion, or evidence or appearance of collusion, between any local official and a representative of AXA Equitable in the selection of AXA Equitable as contractor for the administration of the Service Agreement pursuant to N.J.A.C. Section 5:37-5.7.
- (c) the Borough Administrator is hereby designated as Local Plan Administrator for the administration of the Deferred Compensation Plan.

BE IT FURTHER RESOLVED, that a certified copy of this resolution and all necessary required documents shall be submitted the Director of the Division of Local Government Services within the State Department of Community Affairs for approval; and

FOR DISCUSSION:

Best Practices Inventory

Borough CFO Bascom explained that Best Practices is a series of tests that the state gives municipalities to see if they operate efficiently and effectively and advised that the minimum score to receive 100% of state aid is 80%. Mr. Bascom reported that Sea Bright scored in the 90th percentile. The survey encompasses a wide range of topics including general management of the Borough, finance and audit, procurement, budget preparation and presentation, health insurance and personnel.

COUNCIL COMMITTEE REPORTS:

BEACH / PUBLIC RELATIONS / GRANTS:

Committee Chair Lamia reported the PR committee will be getting together after the election and will prepare a fall update of all projects and activities. Administrator Verruni is setting up a meeting with the beach manager. The dune committee is requesting 2,500 feet of snow fence to put on north beach in an area that will not be disrupted by the seawall project. There is a group that wants to help us with funding and manpower to construct "up and overs" for the dunes. Councilman Lamia is reviewing the 30 minute and 2 hour parking with the businesses and hopes to report back on this shortly. Mayor Long expressed concern about building crossovers on the dunes in regards to the DEP - Councilman Lamia said that he has reviewed all of the DEP guidelines and is making sure we take the proper steps.

FINANCE / INSURANCE / COURT / VOLUNTEERS:

Committee Chair Keeler reported we have budget transfers coming up in November. The application to the State for a 10% match grant has been submitted and if it is accepted that we would be entitled to 100%. The 2017 budget packets will be going out shortly. There will be a meeting with FEMA officials on October 28th to review documents in our files to determine the percentage of the community disaster loans which will be "forgiven." The JIF announced that we will be paying out a \$1million dividend. There are training classes this Thursday focusing on claims and injuries which the Borough Clerk and Chief of Police will both be attending. Councilman Keeler reported the court administrator, Carol Smith, said ,she is very satisfied with everything to do with Sea Bright court. Ms. Smith said the court will more than likely be moving to Fort Monmouth when Oceanport moves their Borough Hall to that location.

PERSONNEL/ LIBRARY / RECREATION:

Committee Chair Bills reported she spoke to Jane Farmer for an update on the library and there are currently over 200 memberships and the library was very well attended during the summer months. There were three children's programs over the summer and there will be another program in December. The winter hours will change: Monday 1pm-5pm Tuesday 10am-2pm, Wednesday 10am-5pm, Thursday 10am-2pm, Friday 1pm-5pm Saturday 9am-12pm. Councilwoman Bills reminded all that Saturday Oct 22nd is the fundraiser for the library which will be sponsored by the businesses – there will be gift baskets and a lot of fun. Trunk or Treat is Saturday, October 29th at 4 pm, followed by the parade at 6 pm and many fun activities for the kids.

PUBLIC SAFETY / EDUCATION:

Committee Chair Rooney reported progress.

<u>PUBLIC WORKS / BUILDING DEPARTMENT / CODE ENFORCEMENT / SEA BRIGHT 365 & CULTURAL ARTS:</u>

Committee Chair Leckstein reported they are continuing to work on the noise ordinance to come up with the best solution of how to proceed. Councilman Leckstein pointed out that tonight Council adopted Resolution 162-2016 which authorizes the Mayor to sign a Memorandum of Understanding between the Borough of Sea Bright and Verizon Communications, First Energy Corp and NJ Natural Gas which was facilitated by Congressman Pallone's office to try to better the relationship between the different utilities in town and the Borough. Reported progress on all other matters.

SEA BRIGHT RECOVERY / CAPITAL PLAN / FLOOD CONTROL/BEAUTIFICATION:

Committee Chair Kelly explained that we will be having a special meeting next Tuesday to hire an architect for a peer review of the plans for the new building projects. This will be an extra layer on top of what our Borough Engineer and Architect are doing which will provide recommendations on all aspects of the project including cost savings. The Borough is scheduling a town hall meeting later in November to further review the final plans with the public. Councilman Kelly reported that since Sandy, the Borough has received approximately \$42.5 million in funding for various projects from insurance, federal and state grants.

Councilman Kelly said we plan to go out to bid for the beach pavilion in November of this year and in December for the municipal building.

He reported we are still waiting on the feedback from the continuous bulkhead application and phase two of the beautification project.

Councilman Kelly reported the streetscape project should begin in November. Once completed, the second phase of the beautification project can begin. Reported progress on all other matters.

MAYOR DINA LONG - Reports and Communications

Mayor Long highlighted what Councilman Kelly mentioned regarding the amount of money that has been invested in Sea Bright since Sandy and that it has made our community more resilient. Our community is blessed that we have the talent and drive of so many people, residents, volunteers, staff and elected officials - it has gotten us so far. We have a special meeting scheduled for October 25th to appoint a review architect and the next regular meeting will be November 14, 2016. Mayor Long briefly reported on the meeting held on October 6th to explore expanding beach access and parking issues with members of the County Parks, Sandy Hook, the American Littoral Society - hopefully there will be further productive conversations to get more people on the beach next summer.

EXECUTIVE SESSION

Councilmember Leckstein offered a motion to enter into Closed Session; seconded by Councilmember Kelly:

WHEREAS, Section 8 of the Open Public Meeting Act, NJSA 10:4-12 permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Sea Bright, New Jersey, that they meet in closed session to discuss the issues as herein set forth and when the need for confidentiality no longer exists the decisions made therein will be made available to the public.

- 2. The general nature of the subject matters to be discussed are as follows:
 - A. Litigation (Attorney/Client Privilege)
- 3. It is anticipated at this time that the subject matters will be made public, if and when confidentiality is no longer needed. Action may be taken.
- 4. This Resolution shall take effect immediately

BE IT FURTHER RESOLVED that the Mayor and Council may come back into Regular Session to conduct additional business.
