The Public Comment portion of this meeting allows members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

Jim Forsman, Sea Bright Fire Department, reported Sea Bright Fire Department's ISO rating increased from Class 4 to Class 3 which could result in property insurance savings for property owners and businesses. Mr. Forsman suggested the Borough do another non-binding referendum to decide how to handle the noise complaints and amending the noise ordinance. Mayor Long thanked all the volunteer members of the fire department for their diligence and record keeping efforts for the improved ISO rating.

Vince Lepore, Long Branch, asked a question on Resolution No. 166-2016 and asked for clarification on what the review architect will be reviewing. Mr. Lepore asked if Resolution No. 167 and No. 168 will be in effect prior to the final review and conclusions of the peer review architect. Mayor Long explained that once an architect is hired, he can make whatever changes the governing body deems necessary. Mr. Lepore reported he attended the last Board of Ed meeting at Shore Regional and asked about any movement taking place before the Commissioner's office. The board attorney responded that there are two conferences taking place in November and a trial date set in the spring. Mayor Long clarified the legal process and noted the Borough is attempting to reach a settlement out of court.
