Murphy Anderson and Laurie Calabrese, 8 Center Street, addressed Council regarding the letter they received from the Borough Attorney advising them that legal action will be taken to recover the outstanding Hazard Mitigation grant money due the Borough for their house lift at 8 Center Street. Mr. Anderson and Ms. Calabrese feel they have been wronged by the Borough, their home is barely habitable and feel it is absolutely shameful that the Borough is "threatening" them for this money. Ms. Calabrese alleged the contract was changed after she signed. Mayor Long stressed she wants to make this right and wants to figure out a way forward.

SUBJECT: 2017 PROPOSED BUDGET

ACTION: Chief Financial Officer Michael J. Bascom reviewed the financial standing of the Borough and presented an overview of the proposed 2017 draft budget. Mr. Bascom reviewed the Annual Debt Statement which reflects a 1.518% net debt ratio which is double where the Borough has been the past 10-15 years but is attributable to the large upcoming projects. Mr. Bascom reported the Sewer and Beach utilities are self liquidating and are covering 100% of their costs. Mr. Bascom reviewed the Annual Financial Statement page by page and answered questions from the governing body.
