**WHEREAS,** on April 21, 2015, the Borough Council of the Borough of Sea Bright awarded a contract to R. Kremer & Son Marine Contractors, LLC of Brick, New Jersey for the Reconstruction of Six Bulkheads and New Stormwater Pump Station in the contract amount \$1,199,880.00; and

**WHEREAS**, on October 20, 2015, Resolution #101-2015 authorized the re-consideration to the base bid, to include Alternate A1, A2, A3 & A4 as submitted in the original bid package that awarded a contract to the lowest responsible bidder, R. Kremer & Son Marine Contractors, LLC of Brick, New Jersey for the Reconstruction of Six Bulkheads and New Stormwater Pump Station in an new contract amount of \$1,525,705.00; and

**WHEREAS,** the Borough Engineer, Jaclyn Flor, submitted Change Order No. 1 dated October 13, 2015, identifying two unforeseen issues with the bulkhead and storm drain installation on South Street resulting in an increase of \$41,517.25 and various items were reduced to reflect current asbuilt quantities resulting in a decrease of \$41,520.00 resulting in a net decrease of \$2.75 to the total contract amount; and

**WHEREAS,** the Borough Engineer, Jaclyn Flor, submitted Change Order No. 2 dated January 5, 2016, identifying a reduction of \$4,080.00 in Items #27, #30 and #A1-15 to reflect the current asbuilt quantities and Item #10 increased \$4,080.00 to reflect current as-built quantities, resulting in a zero cost change; and

**WHEREAS,** the Borough Engineer, Jaclyn Flor, submitted Change Order No. 3 dated February 16, 2016, increasing items No. 8, 9 and 24 which include additional paving, drainage items and adding an inlet necessary to avoid an existing unforeseen sanitary lateral at the end of Osborne Place in an amount not to exceed \$26,750.00; and

**WHEREAS,** the Borough Engineer, Francis W. Mullan, submitted Change Order No. 4 dated October 17, 2016: Item 41) an increase of \$6,500.00 for additional construction efforts to remediate the Osborne Place ponding issues, Item 37) a decrease of \$6,500.00 due to a revision in the testing requirements for the pump station testing on Osborne Place and identified Item A2-1) an increase in the contract of \$37,400 for Kremer's demobilization and remobilization costs as a result of the postponement of the River Street work until April 1, 2017 in an amount not to exceed \$37,400.00; and

WHEREAS, Revised Change Order No. 5 dated June 27, 2017, submitted by the Borough Engineer, Francis W. Mullan, will increase the contract by \$1,093.70, as follows: the contract will be reduced by the remaining balance for each of the completed Items #6,8,9,11, 13-18, 27-30 and A1-16 in the amount of \$41,071.80; extra supplementary items indentified as S-7, S-8, S-9 and S-10 necessary to complete the project will increase the contract in the amount of \$23,415.50; supplementary work identified as S-11 necessary to remove concrete around the existing water main on River Street where the water main enters the river is an increase of \$18,750.00; and, supplementary item S-12 to extend the completion date of Alternate A-2 (River Street) 92 days until September 15, 2017 due to the delay of the water main extension by NJAW; the new contracted amount is \$1,590,945.95.

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 130 "LAND USE", ARTICLE XI, "SIGNS," OF THE CODE OF THE BOROUGH OF SEA BRIGHT, SECTION 130-72, "PERMITTED SIGNS AND AWNINGS IN SPECIFIC ZONES"

#### **ORDINANCE NO. 13-2017**

**WHEREAS**, the New Jersey Department of Environmental Protection requires all communities that contain tidal waters to provide for public access; and

**WHEREAS**, existing and future signage for public access is required at all public access locations identified in the Municipal Public Access Plan; and

WHEREAS, installation and maintenance of signage is a requirement of N.J.A.C. 7:7E-8.11(t).

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Sea Bright in the County of Monmouth, State of New Jersey that Chapter 130, "Land Use," of the Code of the Borough of Sea Bright, shall be amended as follows:

**SECTION ONE**: Section 130-72, "Permitted signs and awnings in specific zones" be and the same is hereby amended and supplemented to add the following subparagraph with all other sections not listed to remain the same:

#### D. Public Access Signs

- (1) "Public Access Signs" shall be a posted sign depicting the public access point to, from and along tidal waterways and their shores within the Borough of Sea Bright. Public Access Signs shall list the name of the access point as well as any restrictions.
- (2) All public access signs shall be installed at the entrance of the public designated access points as outlined in the Municipal Public Access Plan.
- (3) All public access signs shall be maintained by the Department of Public Works.
- E. Awnings (note the re-numbering of "Awnings" language in this section to remain the same)

**SECTION TWO**: All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies

**SECTION THREE**: If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and publication according to law and upon filing with the Monmouth County Planning Board.

#### **COUNCIL COMMITTEE REPORTS:**

#### **BEACH / GRANTS:**

Committee Chair Lamia reported they had a good Fourth of July week - with 4,339 visitors on the guarded beaches over the holiday. The Jr. Lifeguard Program started this past Monday with over 100 participants. The beaches have re-opened in Highlands and our lifeguards are back on duty. Councilman Lamia said the Beach Manager is looking into getting a webcam for the beach with live feed on the website. The Dune Committee is scheduled to meet on July 29 at 9 am to discuss a plan for the fall. Reported progress on all other matters.

#### FINANCE / INSURANCE / COURT / VOLUNTEERS:

Committee Chair Keeler reported the 2016 Audit report has been completed - it is an excellent report with no open questions or negative comments and thanked CFO Mike Bascom for his contributions. We are still awaiting a decision from the State regarding our Sandy loans and the grace period for the 3rd quarter tax payments has been extended because the State and the County are having some procedural problems with the tax data. Councilman Keeler said he will be attending the monthly JIF Safety and Claims meeting and will report back on anything new. Reported progress on all other matters.

#### **PERSONNEL/ PUBLIC RELATIONS / RECREATION:**

Committee Chair Leckstein reported the new digital sign is up and running and the P.R. Committee plans to have the next SeaBreeze issue out in August. Councilman Leckstein reported that movies on the beach have started on Thursday nights; the Farmers' Market is doing extremely well and the turnout has been tremendous this year; yoga on the beach is held on Thursdays as well. Councilman Leckstein reported the planning board adopted the new Master Plan at their last meeting.

#### **PUBLIC SAFETY / EDUCATION / LIBRARY:**

Committee Chair Rooney commended the DPW on the excellent job they have been doing keeping the town clean. The design group will attend the next workshop to go over the furniture and color coordination for the new library. Councilman Rooney reported the police have been very busy - up 40% in writing tickets from Memorial day through fourth of July. Councilman Rooney summed up the statistics on paid parking: in 2015, prior to paid parking, from Memorial Day through this date, we saw 4,138 badge holders, in 2016 during the same timeframe, we saw 6,754 badge holder and this year with 6-7 bad days, we've seen 7,777 - up 3,600 since the implementation of paid parking - it is working! Reported progress on all other matters.

#### **PUBLIC WORKS / BUILDING DEPARTMENT/ CODE ENFORCEMENT:**

Committee Chair Birdsall reported the new working foreman, Shawn Thomas, attended a MEL Leadership Skills Training session for new supervisors June 25 & 26. The DPW has been working really hard and doing a great job keeping the Borough clean and the new landscaped areas weeded and recently installed rope around some of the landscaped areas to keep people from walking over the new plantings. Councilman Birdsall also provided an update on the new permits issued in the building department. Reported progress on all other matters.

#### **SEA BRIGHT RECOVERY/CAPITAL PLAN/FLOOD CONTROL/BEAUTIFICATION:**

Committee Chair Kelly reported the plans for the cell tower are moving along and the permits were dropped off to the building department last week. The pilings for the beach pavilion have been installed and the next phase of significant construction won't begin until the end of August. Councilman Kelly reported plans for the municipal building are being finalized and we should be ready to proceed by the end of August. Regarding Beautification, Councilman Kelly reported we are waiting for proposals for north and south of town. Reported progress on all other matters.

**WHEREAS,** on October 4, 2016, the Borough Council of the Borough of Sea Bright awarded a contract to LandTek Construction d/b/a/ United Terrain Group of Piscataway, New Jersey for the Ocean Avenue Streetscape Improvements Project in the contract amount of \$1,108,996.00; and

**WHEREAS**, on March 7, 2017, Resolution No. 52-2017 authorized Change Order No. 1, to extend the contract completion date from March 29, 2017 to April 13, 2017, Extra: Item 17 – increased to reflect as-built quantities for the project and Supplementary Item S1 - Police Traffic Directors increase in rate in the amount of \$11,317.50 due to current rate change used for Police Traffic Directors in the Borough of Sea Bright increasing the original contracted amount from \$1,108,996.00 to \$1,120,313.50; and

**WHEREAS,** the Borough Council approved Resolution #67-2017 for Change Order No. 2 dated March 21, 2017, to extend the contract completion date for the work between New Street and Church Street from April 13, 2017 to May 4, 2017; Reductions: Item 9 was reduced \$30,000.00 to reflect the upgrade from stamped concrete to pavers at the sidewalk border; Extra: Items 7 and 16 were increased \$12,300.00 to reflect work proposed between Church Street and New Street; Supplementary: Increase of \$81,808.75 as follows - Item S2 was introduced to reflect the upgrade to decorative pavers in the

border area of the sidewalk and Items S3 through S11 were introduced to reflect the additional work required between Church Street and New Street for a net increase in the revised contract amount from \$1,120,313.50 to \$1,184,422.25; and

**WHEREAS,** the Borough Council approved Resolution #84-2017 for Change Order No. 3 dated April 12, 2017, which includes reductions for as-built quantities and additional items for work added to the contract due to field conditions and changes; Reductions of \$80,844.00 for Items 8, 10, 11,13,15,29, 40, 42,48-51, 59, A2-1 and A3-2 were reduced to reflect as-built quantities; Extra: increased the amount by \$4,214.00 for Items 38, 39 and A3-3 that were increased to reflect as-built quantities; and Supplementary: An increase amount of \$29,380.00 for Items S12 through S23 that were introduced to reflect additional various work items required due to field conditions and changes for a net decrease in the amount of \$47,250.00 changing the revised contract amount from \$1,184,422.25 to \$1,137,172.25.

**WHEREAS,** the Borough Council approved Resolution #101-2017 for Change Order No. 4 dated May 16, 2017, to extend the contract to June 23, 2017 to allow for the installation of Item S70-LED Message Sign; Reductions: Items 4-8, 12, 15, 16, 18, 27-29, 41, 44, 47, 50, 56, 57, 58, 60, A2-2, A2-3, A2-6, A2-7, A2-8, A2-9, A2-10 and S5 were reduced by \$119,801.40 to reflect as-built quantities for the project; Extra: increased the amount by \$11,967.00 for Items 2, 13, 30, 38, 39, 40, A3-2 and S1 that were increased to reflect as-built quantities for the project; Supplementary: increased the amount of the project by \$180,999.65 for Items S24 through S72 introduced to reflect the additional various landscaping and work items required due to field conditions and changes for a net increase in the amount of \$73,165.25 changing the revised contract amount from \$1,137,172.25 to \$1,210,337.50.

**WHEREAS,** the Borough Engineer, Francis W. Mullan, submitted Change Order No. 5 dated July 7, 2017, to extend the contract to July 7, 2017 to allow for the installation of Item S70-LED Message Sign and Items 40 and 41 were reduced by \$288.00 to reflect as-built quantities for the project changing the revised contract amount from \$1,210,337.50 to \$1,210,049.50.

Mayor Long commended the DPW for the great job they are doing keeping Sea Bright neat and clean considering all the extra work with the new landscaping. Mayor Long also commended the police for the great job they are doing as well as the beach staff.

Mayor Long reported the bird population is flourishing - there are 10 pairs of piping plovers (endangered species) nesting on the beach this year which is why so much more of the beach is roped off.

Mayor Long advised Council she was approached by representatives working to "Save the Sandlass House" on Sandy Hook and said they are looking to establish a "Jersey Coast Heritage Museum" that will preserve the remaining history from Mr. Sandlass' legacy in the Highland Beach Resort and the beginning of beach clubbing. Mayor Long said they asked if there was an opportunity to create a historical display in one of our new buildings. Councilman Leckstein would like to see exactly what they have in mind as there is also a lot of Sea Bright history that needs a home to be displayed. Councilmember's Leckstein and Kelly will join the Mayor at the next meeting.
