MINUTES WORKSHOP MEETING BOROUGH OF SEA BRIGHT

DECEMBER 14, 2017 (Thursday)

ITEMS FOR DISCUSSION:

SUBJECT: Capital Projects Update

ACTION: Administrator Verruni announced that we advertised for bids for the Municipal Complex which will be received on January 12th. The Beach Pavilion project is going well and continues to be on schedule. Other projects (streetscape and bulkheads) have been closed out and we are working on reimbursements.

SUBJECT: Property Maintenance/Weeds

ACTION: In order to better enforce compliance with the property maintenance ordinance, Chief Sorrentino would like to increase the penalty for offenders. The Chief will work with the Court to put together a draft fee schedule to increase fines.

SUBJECT: Year-round permit parking on side streets

ACTION: Councilmembers have received numerous complaints from residents on certain streets concerning the year-round permit parking on all the downtown side streets. Mayor Long spoke as a "Sea Bright resident" who lives on a downtown street in opposition of this new policy and feels it is a real nuisance for residents. Council discussed other options and will revisit if they receive more complaints.

SUBJECT: Anchorage Parking Lot Safety Issues

ACTION: Councilman Keeler distributed a copy of his recommendations to improve safety in the Anchorage Parking Lot. He has witnessed dangerous situations over the summer and wants to ensure there are no major accidents. In addition, Councilman Keeler made some aesthetic recommendations for the parking lot and seawall. Council discussed and agreed to carry this issue to the next workshop for further discussion.

SUBJECT: Alleyway from Peninsula to River St.

ACTION: Discussion not held.

SUBJECT: Speed Bumps in Downtown/Speed sign

ACTION: Administrator Verruni explained that Chief Sorrentino has recommended purchasing a solar speed indicator that can be moved to different locations on problem streets. If there are continuous problem areas then we can look into installing speed bumps.

SUBJECT: Block 21, Lot 5 - Sale of Borough Property

ACTION: Administrator Verruni reported the property needs to be appraised which will be done in the new budget year. Discussion will be carried until after the appraisal is completed.

SUBJECT: Sewer Deduct Meter Readings

ACTION: The Sewer Collector submitted a letter of recommendation requiring property owners to submit their sewer deduct meter readings by a certain date or else they will be charged at the regular rate. The collector will send out letters and reminders the first year to affected property owners with deduct meters. A resolution will be prepared for the next regular meeting agenda for approval.

SUBJECT: Seasonal Fire Membership/Free beach access

ACTION: Council approved - Administrator Verruni will report back to the Beach Manager and Fire Chief.

SUBJECT: Resolution authorizing the purchase of furniture for the Beach Pavilion/

Library / Community Center

ACTION: A resolution will be prepared for the next regular meeting agenda for

approval.

SUBJECT: Resolution authorizing the acquisition of 1985 Chevy Pick Up Truck - Police

Dept.

ACTION: A resolution will be prepared for the next regular meeting agenda for

approval.

SUBJECT: Beach Concessions/Businesses

ACTION: Administrator Verruni explained that after the first of the year, businesses that have been operating on the beach are going to start applying for 2018 and we need a policy in place. Council had previously agreed to use a bidding process similar to Belmar's policy. Mr. Verruni will put a proposal together for consideration at the January Workshop Meeting. Mr. Verruni discussed building larger cabanas/lockers. Council was supportive of the idea - Mr. Verruni will work with CFO Michael Bascom about covering the initial building costs.
