WHEREAS, the Borough Administrator, Engineer and Attorney reviewed the bid documents and determined the lowest responsible bidder meeting specifications for this bid was Blackrock Enterprises, LLC of Old Bridge, New Jersey for the 2017 and 2018 Roadway and Sewer Improvement Project and recommend that a contract be awarded at a cost not to exceed \$454,881.25.
