Mayor Long called the meeting to order at 7:00 p.m. and requested those present to join in the Pledge of Allegiance.

Chris Capillo, 370 Ocean Avenue asked the Borough Attorney for an update on 376 Ocean Avenue. Mr. McLaughlin responded that all the paperwork has been filed for a default judgement and we are now waiting for confirmation back from the court on a judgement date.

Tom Largey, 1 Beach Way, commented on the stormwater drainage on his street is worse than ever - it floods all the time and the flappers don't work. Administrator Verruni responded that we have applied for a CAFRA permit to extend the drain pipes and install new flappers.

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 150, "PACKAGING PRACTICES – UNIFORM," OF THE CODE OF THE BOROUGH OF SEA BRIGHT, PROVIDING FOR REGULATIONS PERTAINNIG TO PLASTIC BAGS, PLASTIC UTENSILS, FOOD CONTAINERS, BALLOONS AND STRAWS"

Councilmember Leckstein offered a motion to open the public hearing on Ordinance No. 23-2019; seconded by Councilmember Birdsall:

Public Hearing (Ord. No. 23-2019)

Chris Capillo, 370 Ocean Avenue, asked if the ordinance included a ban on Chinese lanterns. Mayor Long responded that they are covered and illegal under the Fire Code.

Tim Zelko, Tommy's Tap and Tavern, asked for clarification and how to determine "single use" concerning to-go containers and bags. The different items were considered and the to-go containers would be acceptable but not the plastic bags. Councilman Leckstein said code enforcement and the police would be enforcing the ordinance.

Frank Bain, Bain's Hardware, said they do not oppose the ordinance but would like to be able to use up the surplus of plastic bags they have already purchased and requested a longer phase-in/grace period.

Fatima, 7-11 Convenience Store, also asked for an extension of the phase-in period.

Christine Carducci, Donovan's Reef, explained that they are complying with all the new guidelines but it would be real hardship to switch to paper cups. Councilman Leckstein said that plastic cups are exempt from the ordinance.

Bowie Kok, Yumi Restaurant, brought in the plastic containers she uses to ask if they were considered multi-use and acceptable under the new ordinance.

Councilman Schwartz reiterated that the point of this ordinance is to start using things that we can reuse – we are trying to get rid of garbage – people won't mind paying a little extra for a reusable bag.

Councilman Rooney said we make our living from this beach and we should be leaders in this area.

Gary Vialonga, Edgewater Beach Club, said they were here because of their concern about a plastic cup ban.

Tom Largey, Beach Way, suggested maybe we aren't going far enough with this ban – as they find more plastic bottles in the ocean than anything else.

Cindy Zipf from Clean Ocean Action spoke about the escalating crisis plastics are creating in our ocean and scientists are saying that by 2050 there will be more plastics in the ocean than fish. There are millions of animals suffering and dying from these plastics. Ms. Zipf reported on the extraordinary amount of plastics that are picked up during the two annual clean up day on our beaches. Ms. Zipf thanked the Council's leadership for including so many items in the ordinance and introduced Peter Blair, Policy Attorney with Clean Ocean Action who will offer some additional suggestions. Peter Blair, said they are concerned about the thicker plastic bags that are considered re-usable which ultimately cause more harm to marine life, balloon releases should be banned from the entire Borough, not just from the beach (include a ban on tethered balloons also) and defining with more detail "single-use or multi-use" plastics.

Attorney McLaughlin asked Mr. Blair to send him the list of recommendations and concerns so Council can discuss and consider incorporating into the ordinance at a future date.

Councilmember Leckstein offered a motion to close the public hearing on Ordinance No. - 2019; seconded by Councilmember Birdsall:

Councilman Leckstein read for the record the request from Giglio's Bait Shop that "wet" bait plastic bags be exempt. Council agreed to consider this request in the new year.

Councilmember Leckstein offered a motion to amend Ordinance No. 23-2019, Section Four, changing the effective date to May 1, 2020 and advertise according to law; a public hearing will be held on this amendment on December 17, 2019; seconded by Councilmember Birdsall:

Darius Ardella, representing 7-11, asked for an exemption for the large straws for the big gulp cups. The Attorney suggested they check to see what alternatives are available over the next month or two.

Chuck McQuillan, Eventide Restaurant, was concerned about the effective date and was told it was moved back to May 1, 2020.

<u>Section 1</u>. The Borough of Sea Bright, in the County of Monmouth, New Jersey, authorizes the acquisition of radio communications equipment for the Fire Department, including all work and materials necessary therefor and incidental thereto for the Borough of Sea Bright, to be funded from the sources specified in Section 2 of the Ordinance.

Section 2. The amount of \$75,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the Borough's Disaster/Insurance Reserve Fund in the amount of \$75,000.

Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Borough determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the Borough of Sea Bright may lawfully make as a general improvement.

<u>Section 4</u>. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.
