SHARED SERVICES AGREEMENT BETWEEN THE BOROUGH OF SEA BRIGHT AND THE TOWNSHIP OF HOLMDEL FOR FISCAL OFFICER

THIS AGREEMENT ("Agreement"), is made this 1st day of August, 2020 by and between

THE TOWNSHIP OF HOLMDEL, a municipal corporation of the State of New Jersey, located in the County of Monmouth, with its principal offices located at 4 Crawfords Corner Road, Holmdel, New Jersey ("Holmdel"); and

THE BOROUGH OF SEA BRIGHT, a municipal corporation of the State of New Jersey, located in the County of Monmouth, with its principal offices located at 1099 Ocean Avenue, Sea Bright, New Jersey ("Sea Bright").

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the "Act"), authorizes local units in the State of New Jersey to enter into agreements with any other local unit to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

WHEREAS, Sea Bright is in need of the services of a Fiscal Officer; and

WHEREAS, Holmdel has agreed to furnish to Sea Bright the services of its Fiscal Officer pursuant to N.J.S.A. 40A:65-1; and

WHEREAS, in the spirit of inter-municipal cooperation in furtherance of the principles underlying the Act, Holmdel and Sea Bright (collectively the "Parties") have negotiated an Agreement for the sharing of personnel for the provision of Fiscal Officer services; and

WHEREAS, the terms and conditions of this understanding are set forth below; and

WHEREAS, the Parties have each duly authorized their proper officials to enter into and execute the Agreement through lawfully adopted resolutions of their respective governing bodies.

NOW, THEREFORE, be it understood as follows:

1. APPLICABLE LAW

This Agreement is governed by N.J.S.A. 40A:65-1 et seq., the Uniform Shared Services and Consolidation Act. This Agreement and any amendments thereto must be authorized in conformance with this Act, and all actions that are taken pursuant to this Agreement shall be in accordance with same.

2. TERM OF AGREEMENT

This Agreement shall take effect on August 1, 2020 (the "Effective Date") and shall remain in full force and effect unless and until terminated in accordance with the provisions herein.

3. SCOPE OF SERVICES

Holmdel shall furnish Sea Bright an employee that is its fiscal officer or similarly titled employee to perform the following services (with the employee referred to as the "Fiscal Officer" in this Agreement):

- 3.1. Maintaining the Borough's general ledger and subsidiary ledgers including Budget, Revenue and Trust.
- 3.2. Reconciling the Borough's bank accounts including assistance to Tax Office in identifying and resolving discrepancies.
- 3.3. Overall corroboration of cash reconciliations and subsidiary ledgers to the general ledger.
 - 3.4. Assistance with current fiscal-year finance related regulatory matters.
 - 3.5. Monitoring of grant fund reserves.
 - 3.6. Assistance with the Borough's statutory audit.
 - 3.7. Set-up of escrow and payroll agency related activity.
- 3.8. Limited interaction for issues not related to current fiscal year/or not within scope of previous period services performed.
- 3.9. Preparation of the 2020 Annual Financial Statement as well as the 2020 Audit statements (including pro-forma notes provided by the Auditor).

At the time of entry into this Agreement, it is understood that Wayne Sibilia, an employee of Holmdel, shall serve as the Fiscal Officer and perform the services provided under this Agreement.

Holmdel recognizes that its employee will spend at least one day per week, except when on vacation, at Sea Bright's governmental offices in order to carry out its obligations under the Agreement.

4. HOLMDEL AS EMPLOYER

Holmdel shall serve as the employer of the Fiscal Officer. Holmdel shall be exclusively responsible for the payment of any and all salary and benefits due and owing to the Fiscal Officer. The Fiscal Officer shall be governed by Holmdel's personnel policies and shall be entitled to any and all rights and benefits that may have accrued from his or her employment with Holmdel.

5. AUTHORIZATION

Pursuant to the provisions of N.J.S.A. 40A:65-5, the governing bodies of the respective parties have duly adopted a resolution that provides for entry into this Agreement.

6. MAINTENANCE OF RECORDS

All records produced by the Fiscal Officer on behalf of Sea Bright shall be retained at Sea Bright's offices.

7. FEE

Sea Bright shall pay Holmdel a fee for the services provided for in this Agreement as follows: (a) \$3,312.50 per month for the services listed in Sections 3.1 through 3.8; and (b) a flat fee of \$4,700 for the services listed in Section 3.9 upon being provided in that calendar year.

These fees shall be subject to an annual increase on January 1 of each calendar year (starting in January 2021) in the amount of the (a) Cost-of-Living Adjustment, as determined annually by the Division of Local Government Services, or (b) 2%, whichever is greater.

Sea Bright shall make all payments required hereunder in equal monthly installments, due by the 20^{th} of each month for the month that services are rendered. The payments may be billed quarterly at the option of Holmdel. Sea Bright shall provide sufficient funds in its budget to cover the cost of its obligations under this Agreement.

8. CONFIDENTIALITY

Each party recognizes and acknowledges that it may have access to certain confidential information of the other party, employment, operations, and financial records and related data which is not otherwise publicly available (the "Confidential Information"). Each party will treat as confidential all Confidential Information of the other party; will implement reasonable procedures to prohibit disclosure, unauthorized duplication, use, misuse or removal of the other party's Confidential Information; and will not use or disclose such Confidential Information, unless such information becomes generally known through no fault of the disclosing party, or unless such party is required by law to disclose such Confidential Information.

9. HOLD HARMLESS AND INDEMNIFICATION

Sea Bright shall indemnify and hold Holmdel, its officers, employees, and agents harmless from and against any and all claims of whatever nature or type arising from the provision of services to Sea Bright under this Agreement. Such indemnification shall include payment of reasonable fess and costs in the defense of any claim made by a third person.

Sea Bright shall maintain commercial general liability, business automobile liability, and professional errors and omissions policies that include Holmdel as an additional insured. Upon entry into this Agreement, Sea Bright shall promptly submit to Holmdel copies of Certificate(s) of Insurance setting forth the required coverages.

Holmdel shall provide workers' compensation coverage to the Fiscal Officer.

10. TERMINATION

Either party may terminate the Agreement at any time and for any reason upon giving the other party one hundred and twenty (120) days' advanced written notice of its intent to terminate.

In the event the Holmdel employee assigned to Sea Bright as Fiscal Officer separates from employment with Holmdel, this Agreement shall be immediately terminable by either party upon notice to the other.

In the event of a termination of this Agreement, the Parties shall take all steps necessary to ensure that the services are transitioned back to the respective party in a manner which does not jeopardize the health, welfare or safety of the residents of either party.

11. DEFAULT

In the event either party defaults in the performance of any of its obligations under this Agreement, after receiving written notice of same and failing to cure such default within thirty (30) days of said written notice, the non-defaulting party shall be entitled to terminate this Agreement effective immediately and shall be entitled to all other remedies available at law, in equity, or both. The non-defaulting party shall also be entitled to receive from the defaulting party all costs and expenses, including legal fees, as a result of such default.

12. CHOICE OF LAW

Any dispute under this Agreement or related to this Agreement shall be governed by and construed in accordance with the laws of the State of New Jersey. The Parties agree that any litigation arising under this Agreement shall be submitted to the exclusive jurisdiction of the Superior Court of New Jersey, Monmouth County Vicinage.

13. ENTIRE AGREEMENT

This Agreement represents the entire agreement between the Parties and may only be modified in a writing duly authorized by resolution of their respective governing bodies. No oral modifications are permitted.

14. SEVERABILITY

If part of this Agreement shall be held to be unenforceable or invalid, the rest of this Agreement shall nevertheless remain in full force and effect.

15. WAIVER

Failure to insist upon strict compliance with any of the terms, covenants, or conditions of this Agreement at any one time shall not be deemed a waiver of such terms, covenants, or conditions at any other time nor shall any waiver or relinquishment of any right or power herein at any time be deemed a waiver or relinquishment of the same of any other rights or powers at any other time.

ORDINANCE NO. 08-2020

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 3, "ADMINISTRATIVE CODE", OF THE CODE OF THE BOROUGH OF SEA BRIGHT, PROVIDING FOR STIPENDS FOR ELECTED OFFICIALS

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Sea Bright in the County of Monmouth, State of New Jersey, as follows:

SECTION ONE: Chapter 3, "Administrative Code," of the Code of the Borough of Sea Bright, be and the same is hereby amended and supplemented to add thereto the following section:

"§3-14. STIPENDS FOR ELECTED OFFICIALS.

- **A.** Annual stipends for the Mayor; Council President and other members of the Borough Council shall be established in the salary ordinance and shall be set by resolution of the Borough Council.
- **B.** This section shall apply only to those officials of the Borough elected to terms commencing on or after January 1, 2021 or appointed to fill vacancies thereafter."

SECTION TWO: All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION THREE: If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and publication as required by law.
