6. 2019 COUNCIL PRESIDENT MARC A. LECKSTEIN: 2019 YEAR-END ADDRESS

Good morning and welcome to Sea Bright's Annual re-organization meeting. For those who attended last year's meeting you may recall that the weather was much the way it is today – dreary – yet I am happy to report that bad weather on re-organization day has shown itself to be a sign of great things to come.

A year ago, I had the honor, as Council President, to be the first Sea Bright official to offer public comments from within these beautiful new council chambers. I was incredibly proud that day of all that this Borough has accomplished since the days of Super Storm Sandy and as I stand here today, that sense of pride has only strengthened. In 2019 we have continued to show the world how anything is possible if people simply listen to one another and work together for a common goal. Teamwork continues to be the mantra here in Sea Bright. The present council behind me, led by our outgoing Mayor Dina Long, has always worked as a united body. Unlike other governmental entities which you hear about far too often in the news today, Sea Bright's Mayor and Council have worked together – regardless of political affiliation or ideology to get the job done. In fact, we often joke amongst ourselves that we don't even know which amongst are Democrats, Republicans or Independents. It just doesn't matter here in Sea Bright. With the recent election of Brian Kelly as our new Mayor, the re-election of Kevin Birdsall and the new addition of Sam Catalano, I know that sense of bipartisanship will only continue to endure.

With the tremendous support of this Council backed by the entire Sea Bright community, we have accomplished amazing things – and honestly, I see no end to our potential on the horizon. Just the other day I read in the news that our own Anjelica's had been ranked by Open Table as one of the top 100 Restaurants in the entire country. I didn't say in Monmouth County. I didn't say in New Jersey. I said the entire country! It is truly amazing what is happening here.

Legislatively the Borough continues to be a progressive leader, just recently having adopted an ordinance which will put an end to the use of plastic bags and utensils. Contrary to what many may have expected, we did this with the overwhelming support of our business community. Why? Because once again, in Sea Bright, we work together to get things done.

I do not want to take up much time here – but I would be remiss if I did not give credit to our tremendous municipal staff that works non-stop to ensure that our town is kept beautiful. Our streetscapes and our beaches have never looked better. We are most definitely the envy of the communities around us.

I want to thank you all for coming out this morning. And now, it is my honor to welcome our new Mayor – and my friend – Brian Kelly.

2020 NEW YEAR MESSAGE

Happy New Year! 2020 will be a great year for Sea Bright. We are going to work hard throughout the year and have a lot of fun along the way.

Thank you, Dina, for the past eight years!

Thank you to all our employees, professionals, and volunteers, which is best said with our new buildings for our essential and community services.

Two state-of-the-art facilities better position Sea Bright to respond more successfully to storms and emergencies.

Thanks to our Governing body, including newly elected Sam Catalano. We are elected officials who volunteer our time week-to-week, year-to-year!

With costs, needs, and taxation all increasing, small towns are vulnerable to change, but we are proving that we are resilient.

Major rebuilding for a generation or two is coming to an end, and we are positioned for a phase of economic growth!

We needed stability first, then growth!

Property values have gone up dramatically in the past five years, which is generally a good thing. Our tax rate was reduced this year, but property taxes can still increase due in large part to an obsolete Shore Regional state tax formula that we will continue to challenge in 2020.

Regarding revenue generation, our Borough has exceeded goals with little to no negative consequences, and we will continue to do so moving forward. Our cell towers met the needs of residents and essential services while generating revenue for Sea Brighters.

Our seasonal municipal paid parking has been in place since 2016 and has been very successful! Initially projected to deliver about \$100,000 to \$150,000 annually to Sea Bright, paid parking generated about \$390,000 in 2019 alone! While the revenue can fluctuate year-to-year, the success is due to careful economic planning and implementation.

We will continue beautification projects into 2020, including the downtown and Anchorage Park, acquired through Blue Acres.

As you can see, Sea Bright has made tremendous progress over the past couple of years, and we are positioned for even greater success and growth moving forward into 2020.

Res. No. 30-2020 AUTHORIZING FIRST AMENDMENT TO THE TEMPORARY CELL TOWER LEASE AGREEMENT WITH T-MOBILE NORTHEAST LLC

Councilmember Leckstein offered the following resolution and moved its adoption; seconded by Councilmember Keeler:

WHEREAS, the Borough of Sea Bright (Lessor) is the owner of property located at the corner of Wayne Street and East Center Street, Block 20, Lot 7, located in the Borough of Sea Bright, County of Monmouth, State of New Jersey; and

WHEREAS, The Lessor and T-Mobile Northeast LLC, a Delaware limited liability company (Lessee), entered into a Temporary Tower Agreement for use of the aforesaid property a for co-location on an existing telecommunications tower dated May 31, 2018 in the amount of \$45,000.00/year; and

WHEREAS, the term of the Temporary Agreement expired on May 14, 2019 and the Borough is desirous to amend and restate the Temporary Agreement as set forth below:

- 1. **Term.** The Lessor and Lessee agree to extend the term of the temporary agreement for a period of twelve (12) months ("Extension Term") commencing May 15, 2019 ("Extension Commencement Date"). The Extension Term shall terminate on the earlier of the date of either the completion of construction of permanent tower and full operation of the Lessee's facilities on the permanent tower or the termination date of May 14, 2020 ("Termination Date"). Any rent for any fractional month from the termination date shall be appropriately prorated.
- **2. Rent.** Effective on the Extension Commencement Date (May 15, 2019), the monthly rent shall increase by \$112.50 (from \$3,750.00 to \$3,862.50).
- **3. Terms; Conflicts.** The terms and conditions of the license are incorporated herein by this reference, and capitalized terms used in this Frist Amendment shall have the same meanings such terms are given the License. Except as specifically set forth herein, this First Amendment shall in no way modify, alter or amend the remaining terms of the License, all of which are ratified by the parties and shall remain in full force and effect. To the extent there is any conflict between the terms and conditions of the License and this First Amendment, the terms and conditions of this First Amendment will govern and control.

- **4. Approvals.** Lessor represents and warrants to Lessee that the consent or approval of no third party, including, without limitation, a lender, is required with respect to the execution of this First Amendment, or if any such third-party consent or approval is required, Lessor has obtained any and all such consents or approvals.
- **5. Authorization.** The persons who have executed this First Amendment represent and warrant that they are duly authorized to execute this First Amendment in their individual or representative capacity as indicated.

NOW, THEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, hereby authorize the Mayor and Borough Clerk to execute the attached First Amendment to the Temporary Tower Lease Agreement (attached hereto) between the Borough of Sea Bright (Lessor) and T-Mobile Northeast LLC, a Delaware limited liability company (Lessee) with the addition of the aforementioned terms.
