No. 40-2022 Consideration of Award Lease Agreement for Surf Camp

Councilmember Birdsall introduced and offered the following resolution for approval; seconded by Councilmember Booker:

WHEREAS, on October 5, 2021, the Borough Council of the Borough of Sea Bright authorized the receipt of bids for summer businesses to operate on the Sea Bright Municipal Beach with the option of a one to five-year lease agreement during the summer season; and

WHEREAS, the Borough Clerk did duly advertise on October 28, 2021 to receive bids no later than 12 noon on November 19, 2021, for vendors to conduct a surf camp on the Sea Bright Municipal Beach for a minimum bid amount of \$100.00 for the first year which would increase 15% each year following; and

WHEREAS, in connection therewith, one (1) bid was received, and the Borough Council rejected said bid and authorized the Borough Clerk to re-advertise on January 6, 2022 to receive bids no later than 12 noon on January 21, 2022, for vendors to conduct a surf camp on a portion of the Sea Bright Municipal Beach for a minimum amount of \$8,000.00 to be paid over the five years of lease outlined in the bid specifications; and

WHEREAS, in connection therewith one (1) bid was received by the Borough Clerk from Lucky Dog Surf School, Sea Bright, NJ for a five-year lease in the total amount of \$8,500; and

WHEREAS, after reviewing the bid documents, the Borough Administrator recommends a five-year lease agreement be awarded to Lucky Dog Surf School, Sea Bright, NJ as per the bid proposal.

No. 42-2022 Approving a Final Payment, Change Order No. 2 and Acceptance of Maintenance Guarantee for the Beach Way Outfall Improvement Contract

Councilmember Birdsall introduced and offered the following Resolution for adoption; seconded by Councilmember Booker:

WHEREAS, in accordance with Resolution No. 68-2021, the Borough of Sea Bright awarded a contract to Capela Construction, Inc. in the amount of \$33,800.00, for the Beach Way Outfall Improvements in the Borough of Sea Bright; and

WHEREAS, by way of Resolution No. 158-2021, Council authorized Change Order No. 1 in the amount of \$12,500 to install a backflow preventer in the outfall line which was not included in the original contract, increasing the total contract amount to \$46,300.00; and

WHEREAS, Borough Engineer, Gregory S. Blash, P.E. of Leon S. Avakian, Inc. submitted a letter to the Borough Clerk dated January 10, 2022, advising of Change Order No. 2, modifying Item No. SA2-1, Landscaping Grass, for a reduction of \$2,500 to the total contract amount; and

WHEREAS, the Borough Engineer further advised that all work for said project has been completed, inspected and found to be in compliance with the approved plans and specifications and recommends release of the final payment in the amount of \$13,380.00.

WHEREAS, as required, Capela Construction, Inc. as Contractor, and Lexon Insurance Company of Texas, as Surety, have provided a two-year Maintenance Bond (No. EACX4008049/ LICX1205167) effective as of the date of substantial completion of the project (August 1, 2021) in the amount of \$11,575.00.

No. 43-2022 Authorizing Special Counsel to Submit a Petition to the Commissioner of Education Seeking Authorization to Hold a Referendum on the Issue of the Creation of a PK-12 All Purpose Regional School District with Sea Bright, Highlands, and Atlantic Highlands

Councilmember Birdsall introduced and offered the following Resolution for adoption; seconded by Councilmember Booker:

WHEREAS, the Borough of Sea Bright ("Sea Bright") is a member of the consolidated Oceanport School District ("Oceanport") pursuant to a 2009 mandatory merger under P.L. 2009, c. 78 (eliminating non-operating school districts) and, by virtue of that membership, students residing in Sea Bright in grades PK-8 are educated in schools operated by Oceanport; and

WHEREAS, Sea Bright is a member of a limited purpose regional school district, Shore Regional High School District ("Shore Regional"), whereby students residing in Sea Bright in grades 9-12 are educated in schools operated by Shore Regional; and

WHEREAS, Sea Bright, the Borough of Highlands ("Highlands"), and the Borough of Atlantic Highlands ("Atlantic Highlands") wished to determine the viability and impact of a proposed school district reconfiguration whereby a new All-Purpose PK-12 Regional School District would be created with Sea Bright, Atlantic Highlands, and Highlands as constituent districts of this new district and which would educate all students residing in the three communities in grades PK-12;

WHEREAS, in an effort to explore this proposed school district reconfiguration, Sea Bright, Highlands, and Atlantic Highlands retained Porzio, Bromberg, & Newman, P.C., to facilitate a feasibility study that would be prepared by Statistical Forecasting, LLC, Porzio Compliance Services, LLC; James L. Kirtland, CPA, and David Corso; and

WHEREAS, in March 2020 Statistical Forecasting, LLC, Porzio Compliance Services, LLC; James L. Kirtland, CPA, and David Corso issued a report that analyzed the financial, demographic, and educational impact of creating a new All-Purpose PK-12 regional school district which would be responsible for educating students residing in Sea Bright, Highlands, and Atlantic Highlands; and

WHEREAS, in January 2022 Statistical Forecasting, LLC, Porzio Compliance Services, LLC; and Steven Cea issued an update to the March 2020 report that analyzed the financial, demographic, and educational impact of creating a new All-Purpose PK-12 regional school district which would be responsible for educating students residing in Highlands, Atlantic Highlands, and Sea Bright; and

WHEREAS, with regard to educational impact, the feasibility study concluded that "[t]he All-Purpose PK-12 Regional District will present distinct advantages" for students from Sea Bright, Highlands, and Atlantic Highlands "as opposed to the status quo given the degree of cooperation, alignment and articulation possible through a unified district from PK-12 in areas of curriculum, instruction, student services, transitions, enrichment, athletics and clubs, governance and leadership;" and

WHEREAS, the feasibility study further concluded "that a new All-Purpose PK-12 Regional District consisting of Highlands, Atlantic Highlands and Sea Bright will have the best opportunity to put in place those characteristics of successful schools and will be best able to respond to demographic, educational, and fiscal challenges in the future" and that "[t]o the extent the Sea Bright students bring greater diversity to these schools, the proposal will have a positive educational impact on students from Highlands and Atlantic Highlands."

WHEREAS, with regard to the financial impact of the possible reconfiguration, the feasibility study concluded that "the increased financial resources that Sea Bright students will bring to the regional district provides the opportunity for greater investments in education resources, programs and services" while still providing long-term tax savings to Sea Bright and moving "to an arguably fairer and more equitable allocation of cost methodology" for all three communities; and

WHEREAS, the criteria established in Section 11(a) of P.L 2021, c.402 paragraphs (2) through (8) have been met as the Feasibility Study demonstrates that the approval of the application:

1. "is not foreseeably likely to increase or exacerbate the segregation of students by racial, socioeconomic, disability, or English Language Learner status..."

2. "consolidates school districts that are in close geographic proximity of each other...;"

3. "to the maximum extent practicable, reduces student seat time and transportation costs;"

4. "possesses the potential for improved efficiency and cost savings;"

5. "possesses the potential to advance an enhanced learning environment for participating school districts;"

6. "coordinates curriculum across schools and grades throughout the proposed limited purpose or all purpose regional district; and"

7. "reflects a documented commitment from the affected boards of education to make good faith efforts to implement practices that promote efficiency and quality of education."

WHEREAS, the proposed regionalization provides for the payment, pursuant to Section 11(c) of P.L 2021, c.402, of "transitional support to the limited purpose or all purpose regional district or consolidated school district..." which is being separated from; and

WHEREAS, as a result, the consultants who prepared the feasibility study recommended "that Highlands, Atlantic Highlands and Sea Bright Regional continue to pursue the creation of a new All-Purpose PK-12 Regional District as outlined in the proposed scenario;" and

NOW THEREFORE BE IT RESOLVED that, after due consideration, Sea Bright has determined that its students can receive an outstanding and fully aligned and articulated PK-12 education by withdrawing from Oceanport and Shore Regional and forming a new All-Purpose PK-12 Regional School District with Highlands and Atlantic Highlands; and

BE IT FURTHER RESOLVED that Sea Bright has determined that there exists good cause to pursue a referendum on the creation of a new PK-12 All Purpose Regional School District with Highlands and Atlantic Highlands so as to provide its voters with the ability to decide how their tax dollars are spent and how their children are educated; and

BE IT FURTHER RESOLVED that Sea Bright seeks to have a referendum placed on the November 2022 ballot with regard to the creation of this new PK-12 All Purpose Regional School District and simultaneously to withdraw from Oceanport and Shore Regional, with approval from the Commissioner of Education pursuant to Section 11 of P.L 2021, c.402; and

BE IT FURTHER RESOLVED that Sea Bright authorizes special counsel, Porzio, Bromberg, & Newman, P.C., to prepare and submit a petition, pursuant to state law, to the Commissioner of Education seeking authorization to hold a referendum on the issue of the creation of a PK-12 All Purpose Regional School District with Sea Bright, Highlands, and Atlantic Highlands and by which passage of such referendum will simultaneously withdraw Sea Bright from Oceanport and Shore Regional; and

BE IT FURTHER RESOLVED that Sea Bright authorizes special counsel, Porzio, Bromberg, & Newman, P.C., to take any and all appropriate action to obtain the aforementioned authorization from the Commissioner of Education and to effectuate same.

ORDINANCE NO. 01-2022 CALENDAR YEAR 2021 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

Councilmember Booker offered a motion to introduce Ordinance No. 01-2022 for a public hearing to be held on February 15, 2022 and advertise according to law; seconded by Councilmember Keeler:

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Sea Bright in the County of Monmouth finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$70,730.68 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

FEBRUARY 1, 2022

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Sea Bright, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Borough of Sea Bright shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$247,557.38. and that the CY 2022 municipal budget for the Borough of Sea Bright be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

MAYOR AND COUNCIL COMMITTEE COMMENTS

Councilman Birdsall commended DPW, the Police Department, and all public safety members who assisted with the storm – everyone did a great job! Mayor Kelly agreed and thanked everyone involved. Chief Friedman stated that all the departments really worked hard and did a good job.

Councilman Bieber reported the next administration committee meeting will be held next week (February 9) and they will be evaluating how they can further implement personnel policies and procedures, data records retention, and enforcing ordinances. He also reported as the Council Liaison to the Planning Board that the last meeting had five residential properties reviewed but it was a relatively quiet month overall for the Planning Board.

Councilman Keeler thanked our first responders for keeping the town safe during the storm this past weekend and applauded the team who remained onsite for the duration of the storm. The new truck we acquired from Deal was picked up and, on the drive back, a number of problems were discovered. Dave Estelle and Jim Forsman worked on the truck out in the cold weather and it is now back in service. Councilman Keeler explained that Resolution No. 41-2022 is just an interim appointment of representatives to the Monmouth County Health Commission giving Council a few months to evaluate their options. The Court is going well and the next session is this Thursday if anyone would like to attend.

Councilman Booker reported the budget meetings will be held on Wednesday. They will be looking specifically at ways to cut back spending on non-essential items and increase revenues. Councilman Booker will present a complete report of the budget meetings after meeting with the Finance Committee.

Mayor Kelly reported we have been working with the Mayors of Highlands and Atlantic Highlands to consider forming a new school district. The resolution on the agenda approved earlier tonight authorized sending the revised Feasibility Study to the State for their review in anticipation of having a referendum in November, 2022. We are also all working on dates to hold town hall meetings in each of the three towns to hold discussions regarding the schools. Mayor Kelly announced the annual budget meetings are being held tomorrow. Mayor Kelly reported progress on all other matters.
