REMARKS FROM THE AUDIENCE (limited to 3 minutes)

The Public Comment portion of this meeting allows members of the audience to bring their concerns or comments to the Mayor and Council's attention. Pursuant to Borough Ordinance 3-2011, a member of the public who wishes to speak shall give his/her name and address for the record and may have up to three minutes to state his/her comments to the Mayor and Council as a Body. If additional time or information is requested, an appointment can be made with the Administrator's office during regular business hours.

Pam Ross, 6 Peninsula Avenue, addressed Council and said she feels that there was not adequate notice for the resolution to formalize the cannabis committee. Councilman Booker explained that this is just part of the Council's due diligence – they are formalizing a committee so they can take a closer look into everything involved to make a more informed decision – which includes getting input from the public. She stressed that there are many people against cannabis sales in Sea Bright and encourages the public to become more involved. Attorney McLaughlin clarified that the formation of this committee is enhancing transparency – there was not a discussion on the subject on the agenda, and, in addition, the formation of this committee was discussed at the June and July workshop meetings and was listed on the 7/19/22 Council meeting agenda when it was officially released on 7/15/22. Councilman Birdsall reiterated that the sole purpose of forming a Cannabis Committee is to gather information to bring back to Council for discussion. Councilman Bieber added that approving this Committee has one intention, to start the process of understanding and learning, including input from people in the town, and ultimately make a recommendation to the Council.

Heather Gorman, 13 New Street, suggested a non-binding referendum question on the ballot in November ballot to actually find out whether or not the community is in favor of a cannabis establishment in town. Councilman Booker will be looking at that as one of the ways to determine how the community feels but said we need to be careful that we don't turn an important vetting process into a political campaign.

Mike Ross, 6 Peninsula Avenue, questioned which members of council are on the cannabis committee and wanted to confirm that they would represent both sides – Councilmembers Booker, Bieber, and Birdsall.

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults and on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational cannabis operations; and

WHEREAS, Section 31a of the Act authorizes municipalities to adopt by ordinance regulations governing the local licensing endorsement, location, manner and times of operation of cannabis establishments and cannabis distributors, and the location and manner of cannabis delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, the Mayor and Council wish to determine what regulations governing cannabis are appropriate, and in the best interest of the health, safety and welfare of Sea Bright's residents and members of the public; and

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey does, hereby appoint a Mayor's Blue Ribbon Committee, pursuant to Chapter 3-7 of the Code of the Borough of Sea Bright, which shall act as the Cannabis Committee to research and in due course make recommendations to the Governing Body to establish cannabis regulations within the Borough; and

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SEA BRIGHT, IN THE COUNTY OF MONMOUTH AND STATE OF NEW JERSEY, AS FOLLOWS:

<u>Section 1</u>. The Borough of Sea Bright, in the County of Monmouth, New Jersey, authorizes the acquisition of equipment for the Police Department, Fire Department and Administration, including but not limited to, a breath alcohol testing unit, personal protective equipment, self-contained breathing apparatus, office equipment and other similar equipment for the Borough of Sea Bright, to be funded from the sources specified in Section 2 of the Ordinance.

<u>Section 2</u>. The amount of \$60,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the Borough's General Capital Fund in the amount of \$60,000.

MAYOR AND COUNCIL COMMENTS

Councilman Bieber reported on behalf of the Administration Committee that their top priority right now is bulkhead improvements to mitigate flooding and they have been working on a plan to make the town more resilient – Councilman Bieber highlighted the steps the committee has taken to date. As the Planning Board liaison, he provided an update on what has been going on the last couple of months – there have been 4 new residential applications and highlighted that they approved Beachfront Joe to open a sub shop. The approval is contingent on the owner taking down the current structure on the property within sixty days.

Councilman Catalano reported that the beach camera installation was delayed but should be up and running soon. Beach badge sales remain steady and the numbers are ahead of last year. The junior lifeguard program has started session two and is going well. We have four Plovers in North Beach and two American Oystercatchers in South Beach. Councilman Catalano reported there were 23 water rescues in June and said Beach Manager Don Klein requested a foot washing station by the volleyball court entrance behind old boro hall – he will research options and report back.

Councilman Keeler reported the Court is very pleased with current operations but have been receiving many complaints about parking tickets. Regarding Shrewsbury Way, Councilman Keeler reported we are working with the same contractor that did Anchorage Park, for the walkway from the road to the splash pad. In conjunction with this, the Fire Department and Public Works will assist in washing the deck and stairs at this public access point to prepare them to be painted. A Public Safety meeting will be at the end of the week to discuss ongoing safety improvements throughout the town as well as updates from the NJDOT on our requests.

Councilman Birdsall looks forward to continuing progress in the Department of Public Works as Rob Smith starts his new position on Monday as Deputy Director. Unfortunately, visitors are leaving a lot of garbage and our crew is doing their best to keep up with it. The check valves should be coming in this week and will be installed soon.

Mayor Kelly reported the school regionalization is a huge work in progress but we are working directly with our professionals, Borough administration and the Mayors of Highlands and Atlantic Highlands and our petition was submitted to the Commissioner of Education last Friday. We are aiming to get the referendum question on the upcoming general election ballot – we have a tight time frame but we are working closely with our stakeholders to get this accomplished. Mayor Kelly also stated that we are grateful to be receiving seven donated defibrillators being arranged by the family of the young man who had a heart attack on our beach last year. Progress on all other matters.
