ORDINANCE NO. 06-2025

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 201, "VEHICLES AND TRAFFIC", OF THE CODE OF THE BOROUGH OF SEA BRIGHT

BE IT ORDAINED by the Borough Council of the Borough of Sea Bright in the County of Monmouth, State of New Jersey, as follows:

SECTION ONE: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article II, "Parking Regulations" Section 201-7, "Violations and Penalties", be and the same is hereby amended and supplemented to read, in full, as follows:

- "A. Any person who violates § <u>201-6A</u> above shall be subject to a fine in the amount of \$200.
- **B.** Any person who violates § <u>201-6B</u> above shall be subject to a fine in the amount of \$200.
- C. Any person who violates § <u>201-6C</u> above shall be subject to a fine in the amount of \$200."

SECTION TWO: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article II, "Parking Regulations" Section 201-9, "Violations and Penalties", be and the same is hereby amended and supplemented to read, in full, as follows:

"A. Any person who violates § 201-8 above shall be subject to a fine in the amount of \$200."

SECTION THREE: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article II, "Parking Regulations", Section 201-12, "Loading and Unloading" subsection 201-12C, be and the same is hereby amended and supplemented to read, in full, as follows:

"C. Any person who violates § <u>201-12</u> above shall be subject to a fine in the amount of \$200."

SECTION FOUR: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article IV, "Municipal Parking" Section 201-27, "Violations and Penalties", be and the same is hereby amended and supplemented to read, in full, as follows:

"A. Any person who violates this article shall be subject to a fine in the amount of \$200."

SECTION FIVE: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article V, "Residential Permit Parking", Section 201-34, "Violations and Penalties" subsection 201-34A, be and the same is hereby amended and supplemented to read, in full, as follows:

"A. Any person who parks a vehicle on a street posted "residential permit parking only" without a valid residential parking permit shall be subject to a fine in the amount of \$200."

SECTION SIX: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article VII, "Business Permit Parking", Section 201-48, "Violations and Penalties" subsection 201-48A, be and the same is hereby amended and supplemented to read, in full, as follows:

"A. Any person who parks a vehicle in a space/area posted "business permit parking only" without a valid business parking permit shall be subject to a fine in the amount of \$200."

SECTION SEVEN: Chapter 201, "Vehicles and Traffic", of the Code of the Borough of Sea Bright, Article VIII, "Sea Bright/Rumson Bridge Attendant Parking" Section 201-50, "Violations and Penalties", be and the same is hereby amended and supplemented to read, in full, as follows:

"A. Any unauthorized person who parks in a reserved space shall be subject to a fine in the amount of \$200.".

SECTION EIGHT: All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION NINE: If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION TEN: This Ordinance shall take effect immediately upon its passage and publication according to law and upon filing with the Monmouth County Planning Board.
