WHEREAS, the request for proposals for various professional services was posted, and advertised in the Asbury Park Press to be received on November 28, 2017; and,

WHEREAS, while the Local Public Contracts Law (N.J.S.A. 40A:11-5 (1)(a) does not require competitive bidding for this position, it was nevertheless advertised pursuant to the fair and open process (N.J.S.A. 19:44A-20.5); and

WHEREAS, the seven (7) proposals for Borough Tax Appeal Attorney were received on November 28th from 1) Cleary, Giacobbe, Alfieri, Jacobs, LLC; 2) Dasti, Murphy, McGuckin, Ulaky, Koutsouris and Connors P.C.; 3) DiFrancesco, Bateman, Kunzman, Davis, Lehrer & Flaum, P.C.; 4) Eric M. Bernstein & Associates, LLC; 5) Grace Marmero & Associates, LLP; 6) Rainone, Coughlin, Minchello and 7) Weiner Law Group, LLP; and

WHEREAS, the proposal received from Cleary, Giacobbe, Alfieri, Jacobs, LLC of Matawan, New Jersey is being considered for the term of one year (January 1, 2018 - December 31, 2018) at the rate of \$150.00 per hour; and


