

RESOLUTION NO. 174-2022
CONSIDERATION OF BID RECEIVED FOR
FY2021 AND FY2022 MUNICIPAL AID PROGRAMS
FOR ROAD IMPROVEMENTS – FIORE PAVING CO., INC.

Councilmember Birdsall introduced and offered the following Resolution for adoption; seconded by Councilmember Bieber:

WHEREAS, by way of Resolution No. 130-2022 duly adopted on June 21, 2022, the Borough of Sea Bright approved a proposal for professional engineering services from Remington & Vernick Engineers, Inc., for the New Jersey Department of Transportation's (NJDOT) Fiscal Year 2021 and 2022 Municipal Aid Programs for the New Street, Peninsula Avenue, Imbrie Place, Osborne Place and Surf Street Roadway Improvements Project; and

WHEREAS, the Engineer did duly advertise on October 7, 2022 to receive bids on October 18, 2022 for the New Jersey Department of Transportation's (NJDOT) Fiscal Year 2021 and 2022 Municipal Aid Programs for New Street, Peninsula Avenue, Imbrie Place, Osborne Place and Surf Street Roadway Improvements Project; and

WHEREAS, in connection therewith, two (2) bids were received by the Borough of Sea Bright on October 18, 2022, as follows: 1) Fiore Paving Co., Inc., Oceanport, New Jersey, Base Bid #1 (FY2021) \$158,149.25, Base Bid #2 (FY2022) \$228,258.00 – total bid amount \$386,407.25; and 2) Fernandes Construction, Inc., Monroe, New Jersey, Base Bid #1 (FY2021) \$139,914.01, Base Bid #2 (FY2022) \$252,023.24 – total bid amount \$391,937.25; and

WHEREAS, the Borough Administrator, Engineer and Attorney have reviewed the bid documents and determined Fiore Paving Co., Inc., Oceanport, NJ meets the specifications for the road improvements project for the FY2021 and FY2022 Municipal Aid Programs and recommend that a contract be awarded in an amount not to exceed \$386,407.25.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the following:


