AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES FOR WIRELESS TELECOMMUNICATIONS CONSULTING SERVICES TO FSD ENTERPRISES, LLC

Councilmember Booker introduced and offered the following Resolution for its adoption; seconded by Councilmember Catalano:

WHEREAS, the Borough of Sea Bright has a need to acquire consulting services from a wireless telecommunications consultant as a non-fair and open contract pursuant to the provision of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Borough Administrator has determined and certified in writing that the value of the acquisition may exceed \$17,500; and

WHEREAS, the anticipated term of this contract is one year (January 1, 2023 – December 31, 2023); and

WHEREAS, FSD Enterprises, LLC has set forth its proposed services in a written proposal dated January 23, 2020, a copy of which is available at the office of the Borough Clerk; and

WHEREAS, the proposed amount of the contract with FSD Enterprises, LLC includes a \$3,000.00 initial retainer, and thirty-five percent (35%) of the gross first year lease payment from each wireless telecommunications tenant secured through FSD Enterprises, LLC's services; and

WHEREAS, FSD Enterprises, LLC has completed and submitted a Business Entity Disclosure Certification which certifies that FSD Enterprises, LLC has not made any reportable contributions to a political or candidate committee in the Borough of Sea Bright in the previous one year, and that the contract will prohibit FSD Enterprises, LLC from making any reportable contributions through the term of the contract, and

WHEREAS, the Borough Council has determined it is in the best interest of the Borough to retain FSD Enterprises, LLC as the Borough's Wireless Telecommunications Consultant according to the terms and conditions as set forth in its proposal; and
