RESOLUTION NO. 126-2025 AUTHORIZING SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF HOLMDEL AND THE BOROUGH OF SEA BRIGHT APPOINTING CHIEF FINANCIAL OFFICER

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 <u>et seq.</u> ("Act"), authorizes local units in the State of New Jersey to enter into agreements with any other local unit to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

WHEREAS, N.J.S.A. 40A:9-140.10 requires each municipality to have a Chief Financial Officer and expressly permits the same to be fulfilled by the sharing of a Chief Financial Officer pursuant to a shared services agreement entered into under the Act; and

WHEREAS, Sea Bright is in need of a certified Chief Financial Officer; and

WHEREAS, the Township of Holmdel has agreed to furnish to Sea Bright the services of a Chief Financial Officer, Wayne Sibilia, pursuant to N.J.S.A. 40A:9-140.10; and

WHEREAS, in the spirit of inter-municipal cooperation in furtherance of the principles underlying the Act, Holmdel and Sea Bright have negotiated an Agreement for the sharing of personnel for the provision of a Chief Financial Officer for an annual amount of \$89,946.00; and

WHEREAS, the Borough Administrator and Attorney have reviewed and approve of said shared services agreement and recommend appointing Wayne Sibilia, Chief Financial Officer, in the Borough of Sea Bright.
