

RESOLUTION NO. 150-2025
AUTHORIZING THE PURCHASE OF POLICE DEPARTMENT VEHICLE
2025 CHEVROLET TAHOE

Councilmember Leckstein introduced and offered for adoption the following Resolution; seconded by Councilmember Bieber:

WHEREAS, the Borough of Sea Bright Police Department has the need to purchase a new police vehicle; and

WHEREAS, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29, the Borough of Sea Bright may by resolution and without advertising for bids purchase any goods or services through the State of New Jersey's Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Borough of Sea Bright wishes to purchase a 2025 Chevrolet Tahoe from Robert Green Auto & Truck Inc., Route 17 East, Rock Hill, NY 12775, under County of Onondaga, New York, Cooperative Purchasing Program, ID Number 5126, for a base amount of \$56,564.50 and the necessary police apparatus installed from East Coast Emergency Lighting, 200 West Drive, Millstone, NJ, State Contract #17-FLEET-00761 in the amount of \$20,744.70 for a total cost of \$77,309.20; and

WHEREAS, the purchase under NY State Contract is appropriate and will lead to cost savings for the Borough.
