## RESOLUTION NO. 159-2025 A RESOLUTION OF THE BOROUGH OF SEA BRIGHT APPROVING TWIN LIGHTS BREWING, LLC TO SELL AND SAMPLE LICENSED ALCOHOLIC BEVERAGES AT THE SEASONAL FARM MARKET

Councilmember Bieber introduced and offered for adoption the following Resolution; seconded by Councilmember Keeler:

**WHEREAS,** Pursuant to P.L. 2021 c. 15 and SR 2021-01, the Division of Alcoholic Beverage Control (the "Division") may issue permits allowing the holders of certain manufacturing licenses to sell those licensees' products in original containers at seasonal farm markets for consumption off the premises of the seasonal farm market and to offer samples for sampling purposes, all subject to conditions of SR 2021-01 and of the particular permit; and,

**WHEREAS,** those conditions include that the products must have been produced in Twin Lights Brewing LLC, licensed premises, that the products must be sold in their original containers at the seasonal farm market to be consumed off premises and that Twin Lights Brewing LLC, may offer samples for sampling purposes to persons of the legal age to consume alcoholic beverages in specified amounts; and,

**WHEREAS,** The Division issued Twin Lights Brewing LLC, Seasonal Farm Market License No. 3405-11-203-001 on July 16, 2025, permitting Twin Lights Brewing LLC, to sell licensed products at the seasonal farm market on the basketball court at 1097 Ocean Avenue subject to certain conditions; and,

**NOW THEREFORE BE IT RESOLVED,** by the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, as follows:

- 1. Twin Lights Brewing LLC is permitted to possess and sell alcoholic beverages at the Seasonal Farm Market July 16, 2025 through September 3, 2025, subject to and all the conditions of the Seasonal Farm Market License No. 3405-11-203-001 and this resolution.
- 2. Twin Lights Brewing LLC is permitted to offer samples for sampling purposes at the seasonal farm market July 16, 2025 through September 3, 2025, subject to all the conditions of the Seasonal Farm Market License No. 3405-11-203-001 and this resolution.
- 3. The conditions include, but are not limited to, the following:
  - Twin Lights Brewing LLC may only sell its own products that are produced on its licensed premises;
  - b. Twin Lights Brewing LLC may only sell its products in their original containers for consumption off premises;
  - c. Twin Lights Brewing LLC may offer samples of the products only to persons of the legal age to consume alcoholic beverages;
  - d. Twin Lights Brewing LLC shall not sell, serve or allow service of any alcoholic beverages to any person under the legal age to consume alcoholic beverages nor to any person who is actually or apparently intoxicated; and
  - e. The Seasonal Farm Market Permit must be conspicuously displayed;

This Permit may be canceled at the discretion of the Borough Administrator and/or 4. the Chief of Police if any violations of the Seasonal Farm Market License No. 3405-11-203-001 or this resolution occur or if other good cause exists.
