**WHEREAS,** the Borough Council of the Borough of Sea Bright wish to enter into such an agreement for the 2026 season, for the operation of a temporary municipal parking lot at the rate of \$40.00/per day.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey that it does hereby authorize the Borough Administrator to execute an agreement with 1135 Ocean Avenue, LLC for the use of the parking lot at 1135 and 1139 Ocean Avenue according to the terms and conditions in the attached agreement, throughout the 2026 summer season; and
