

**RESOLUTION NO. 175-2025**  
**AUTHORIZING ENGINEERING SERVICES FOR BULKHEAD INSPECTIONS**  
**BOROUGH OF SEA BRIGHT**

Councilmember Leckstein introduced and offered the following Resolution for adoption; seconded by Councilmember Bieber:

**WHEREAS**, pursuant to Chapter 130, "Land Use," Article IX, "Design Standards for the Specific Uses," Section F, "Bulkheads" of the code of the Borough of Sea Bright, bulkhead maintenance regulations were established to provide the preservation of safe and protective bulkheads within the Borough; and

**WHEREAS**, pursuant to Chapter 130, "Land Use," Article IX, "Design Standards for the Specific Uses," Section G, "Bulkhead maintenance," it shall be the duty of the Borough Engineer to inspect, from time to time, all waterfront bulkheads in the Borough and to report to the Council and notify the owners and occupants of the property on which the bulkhead is located of the existence of any dangerous or defective condition; and

**WHEREAS**, the Borough Engineer, Gregory S. Blash, has submitted a proposal for the inspection of the bulkheads north of the Sea Bright/Rumson Bridge to the northern limits of the Borough and the bulkheads located south of Osborne Place to the southern limits of the Borough for an amount not to exceed \$5,000.00; and

**WHEREAS**, the proposal is conditional upon the residents granting access to their properties to perform the inspections.

**CERTIFICATION OF FUNDS**

I, Wayne M. Sibilia, Chief Financial Officer of the Borough of Sea Bright do hereby certify that \$5,000.00 will be available in Budget Line Item No. 5-01-20-165-228 for the purposes stated herein.

**NOW, THEREFORE, BE IT RESOLVED** that the Borough Council of the Borough of Sea Bright, County of Monmouth, State of New Jersey, hereby approve the proposal submitted by Borough Engineer, Gregory S. Blash of Leon S. Avakian, Inc., dated July 28, 2025, for professional engineering services associated with the inspection of existing bulkheads within the Borough of Sea Bright for an amount not to exceed \$5,000.00; and

**BE IT FURTHER RESOLVED** that a certified copy of this Resolution be forwarded to the following:


