

RESOLUTION NO. 177-2025
**AUTHORIZING THE PURCHASE OF RADIO AND COMMUNICATIONS EQUIPMENT
TO BE INSTALLED IN NEW AERIAL TRUCK FOR SEA BRIGHT FIRE RESCUE**

Councilmember Leckstein introduced and offered for adoption the following Resolution; seconded by Councilmember Bieber:

WHEREAS, by way of Resolution No. 144-2023 approved on September 5, 2025, the Borough Council authorized the purchase of one E-One Aerial, Rear Mount, Aluminum, Typhoon HP 75 Ladder truck for Sea Bright Fire Rescue; and

WHEREAS, Sea Bright Fire Rescue is expecting delivery of the above-mentioned truck and has the need to purchase new radio and communications equipment to be installed in said truck; and

WHEREAS, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29, the Borough of Sea Bright may by resolution and without advertising for bids purchase any goods or services through the State of New Jersey's Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Borough of Sea Bright wishes to purchase radio and communications equipment for the newly acquired fire truck from Motorola Solutions, Inc. c/o Wireless Solutions, Inc., 153 Cooper Road, W. Berlin, NJ 08091, under NJ State Contract No. 83909, for a total cost of \$15,562.50; and
